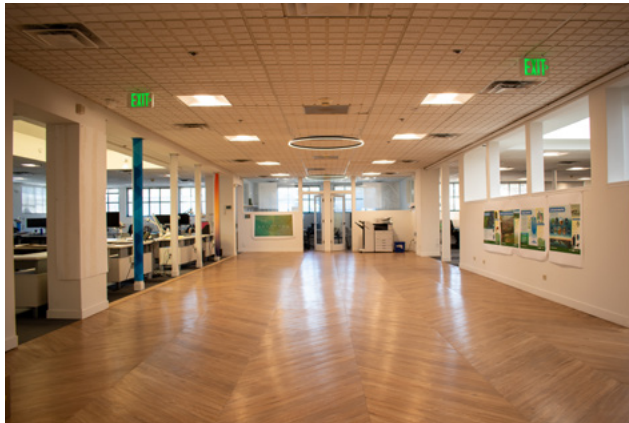
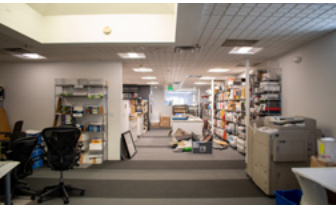

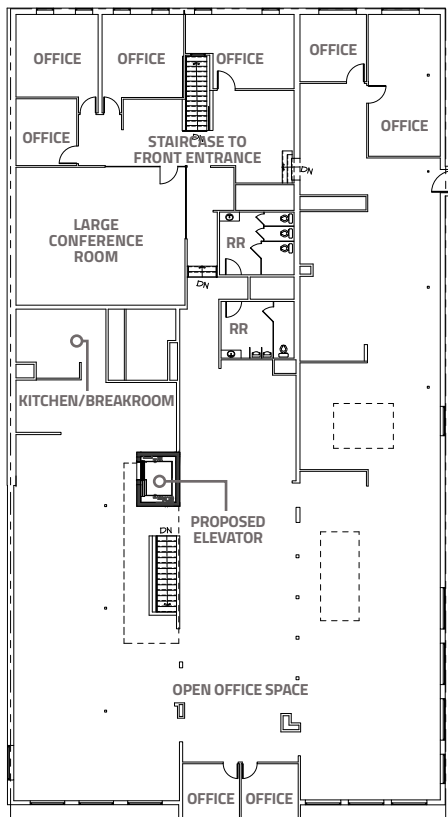




Covered Parking

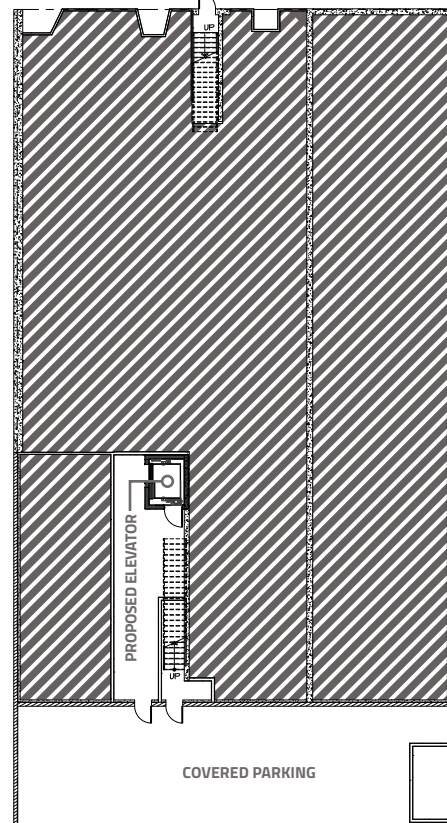
2ND FLOOR

PEARL STREET

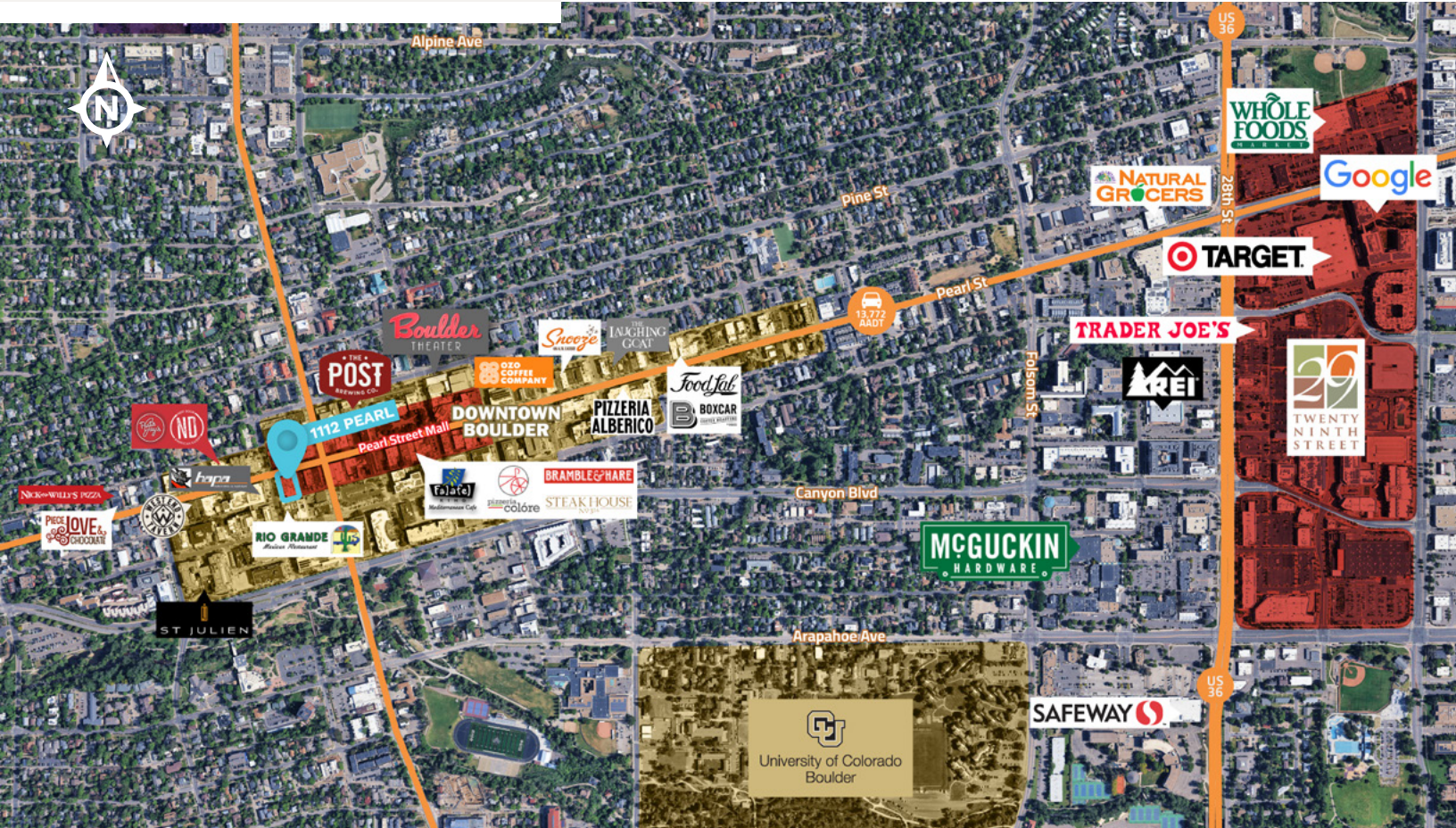


1ST FLOOR
