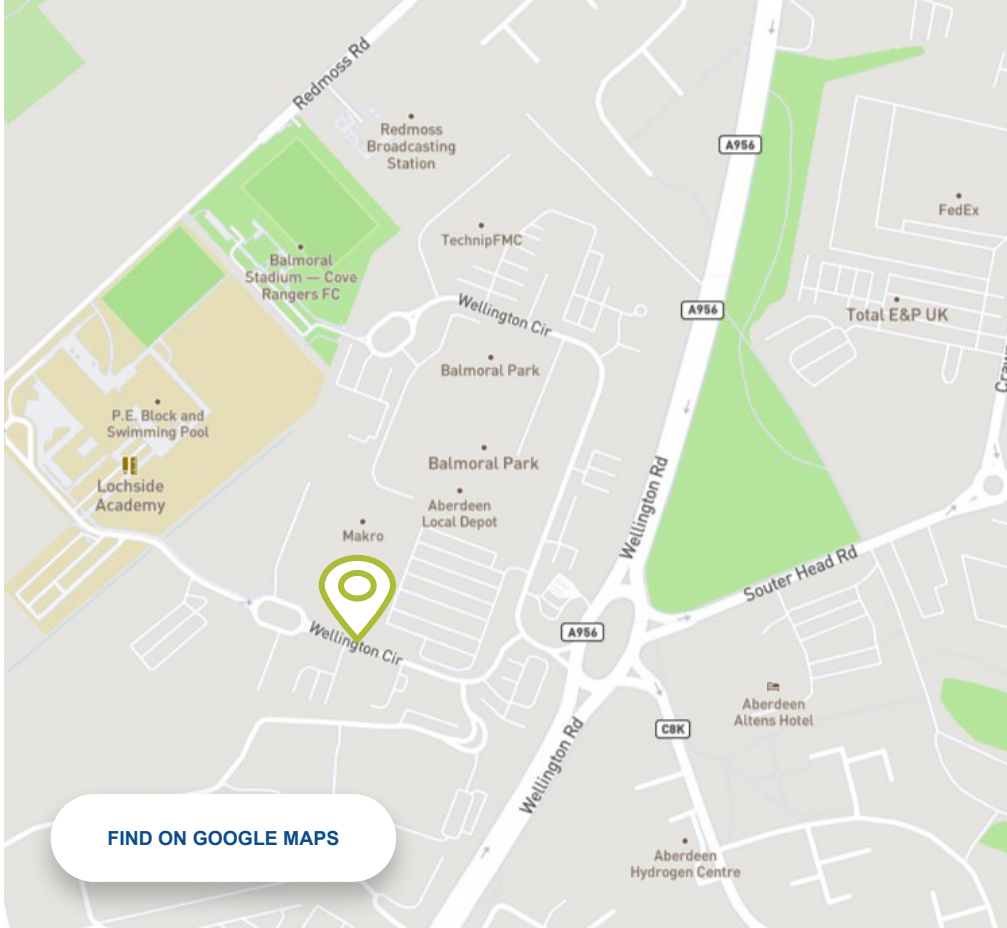

LOCATION

The property is located within Wellington Business Park on Wellington Circle, Altens. Altens is one of Aberdeen's most well-established and popular office and industrial locations and is situated approximately two miles south of the city centre.

Wellington Circle is directly accessed from the main A956 road, which leads north to Aberdeen City Centre, the harbour and railway station and south to the A90 trunk road, AWPR (Aberdeen Western Peripheral Route) and motorway network beyond.

Nearby occupiers include; Makro, Starbucks, Burger King, Balmoral Group, Pure Gym, Royal Mail and Tesla.

DESCRIPTION

The subjects are situated within an established business park of terraced industrial units.

The units are of steel monopitched frame construction with profile metal cladding to the main walls and roof.

Internally, Unit 7B benefits from an open plan single storey layout with a concrete floor, WC facilities and a kitchen / tea prep area to the rear of the unit.

Unit 8 is of similar specification, while further benefiting from a dedicated open plan office / showroom at both ground and first floor level.

Each unit benefits from concertina style electric doors, which provide vehicular access, 3 phase power and 7 dedicated parking spaces within the car park situated to the front of the subjects.

Overall the subjects present in excellent condition and are ready for immediate occupation.
