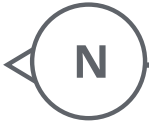
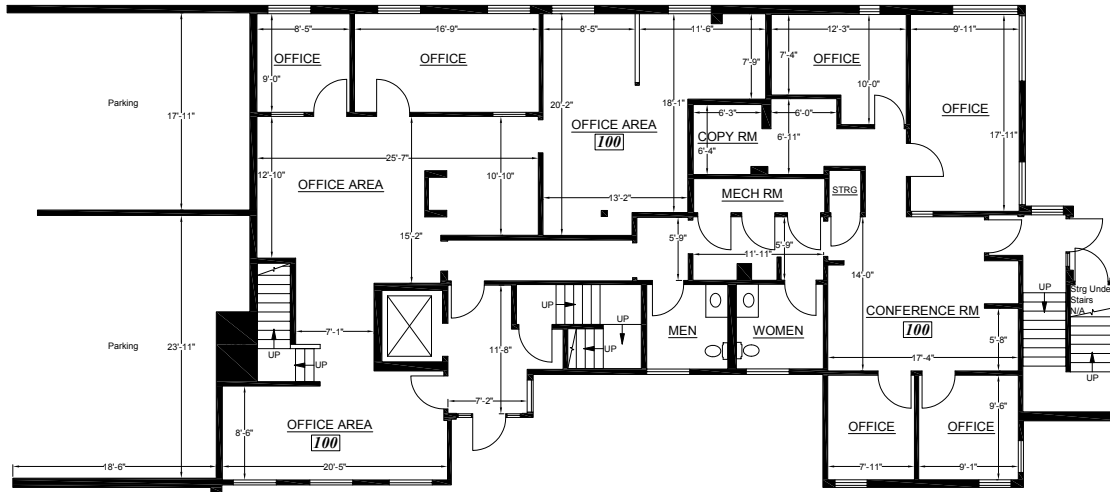
Parcel Map



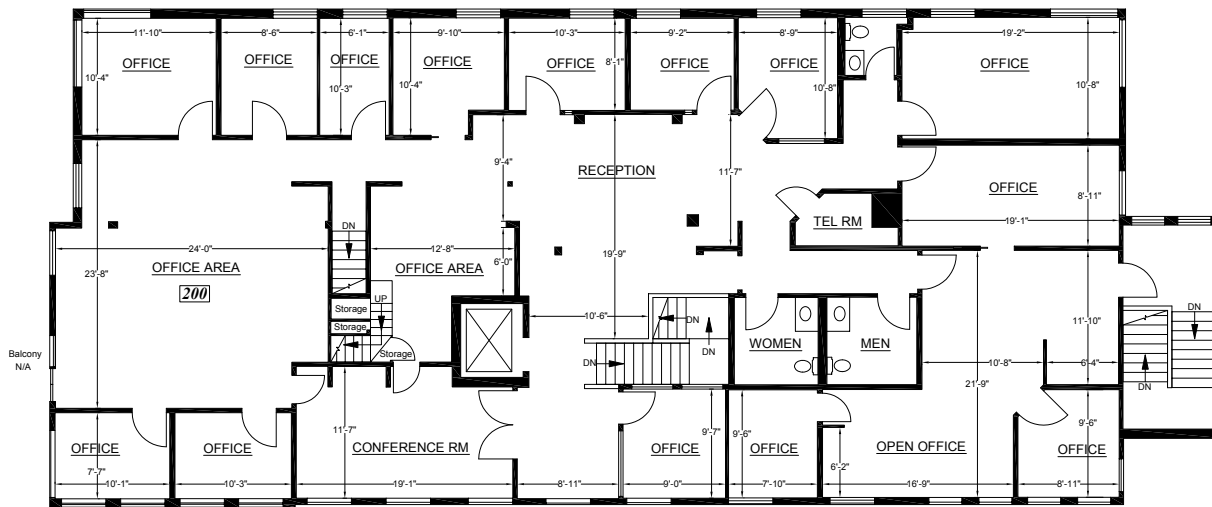

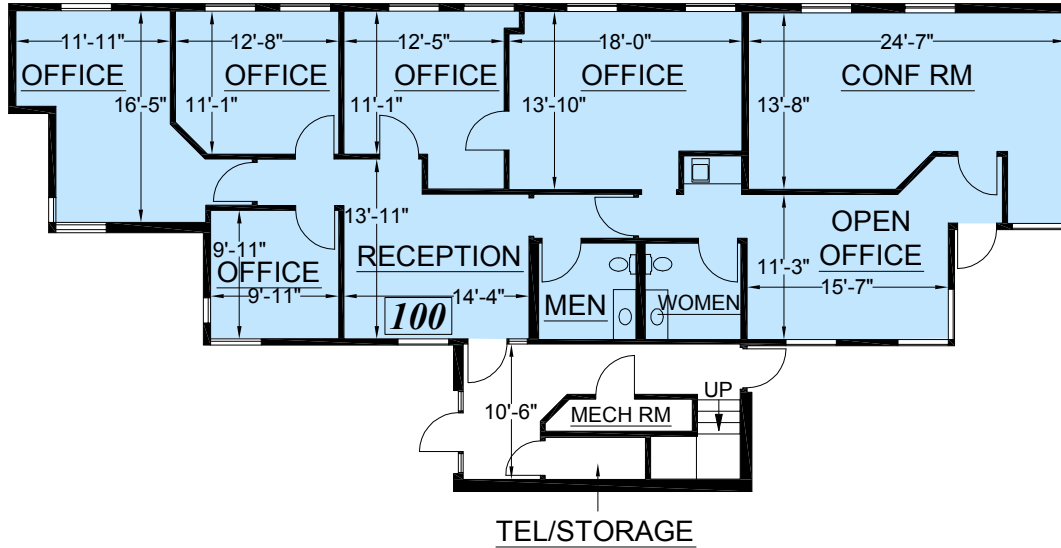

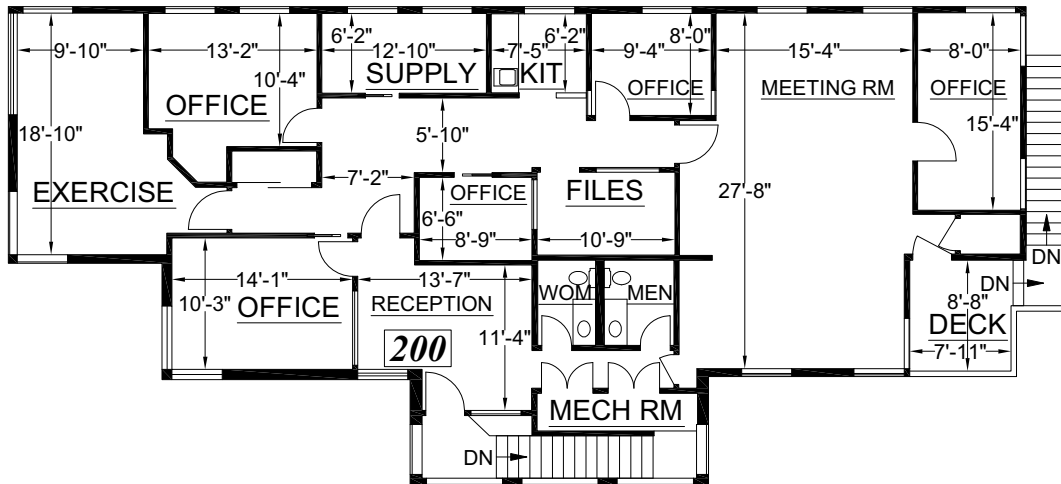

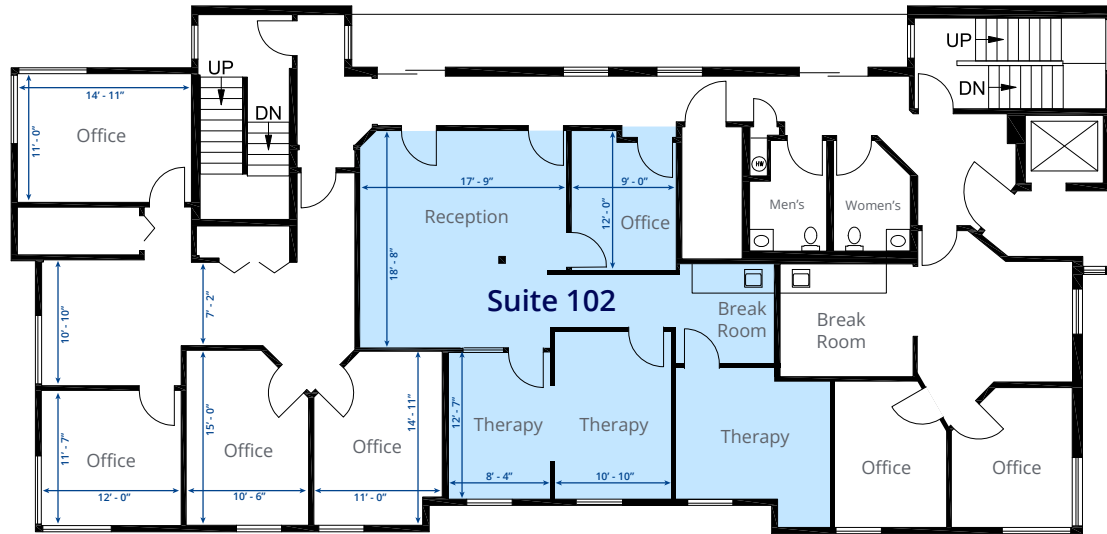

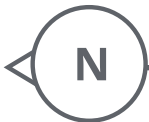

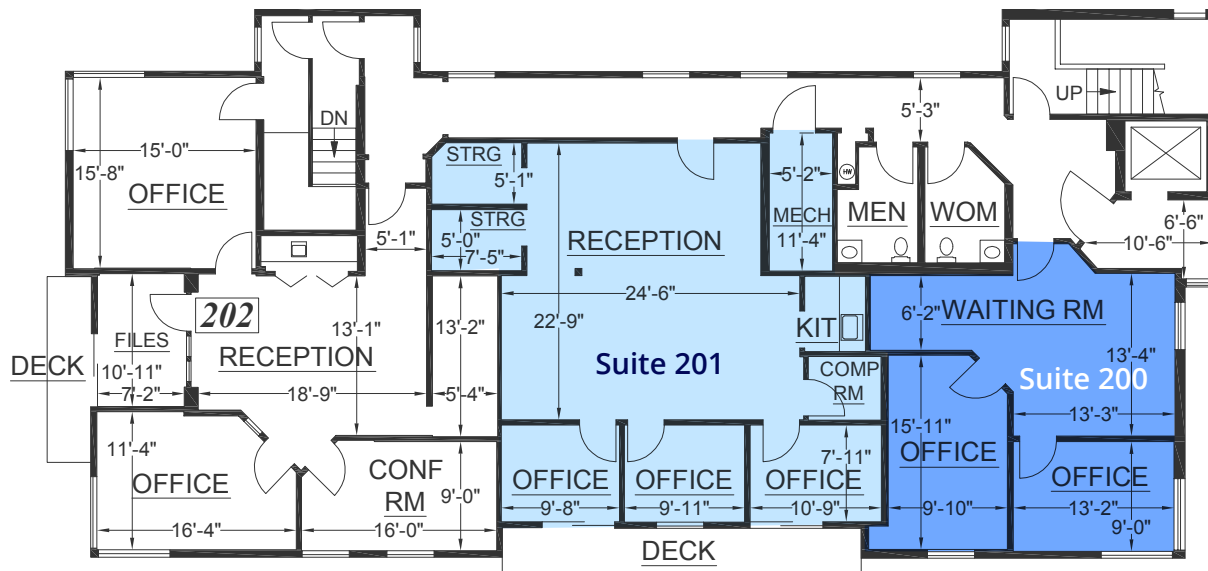

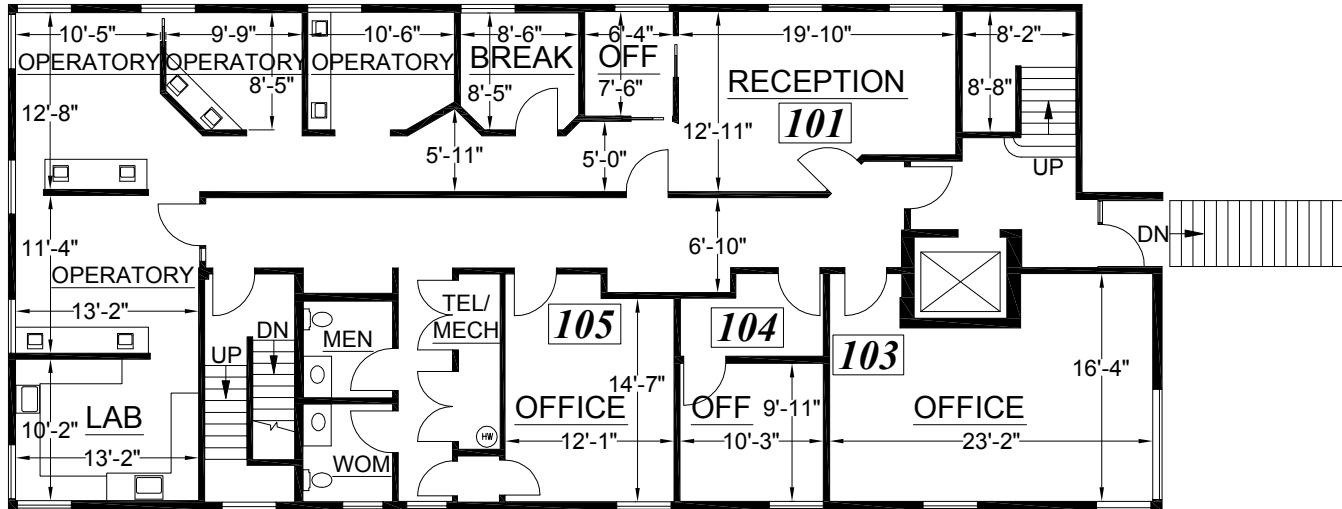
