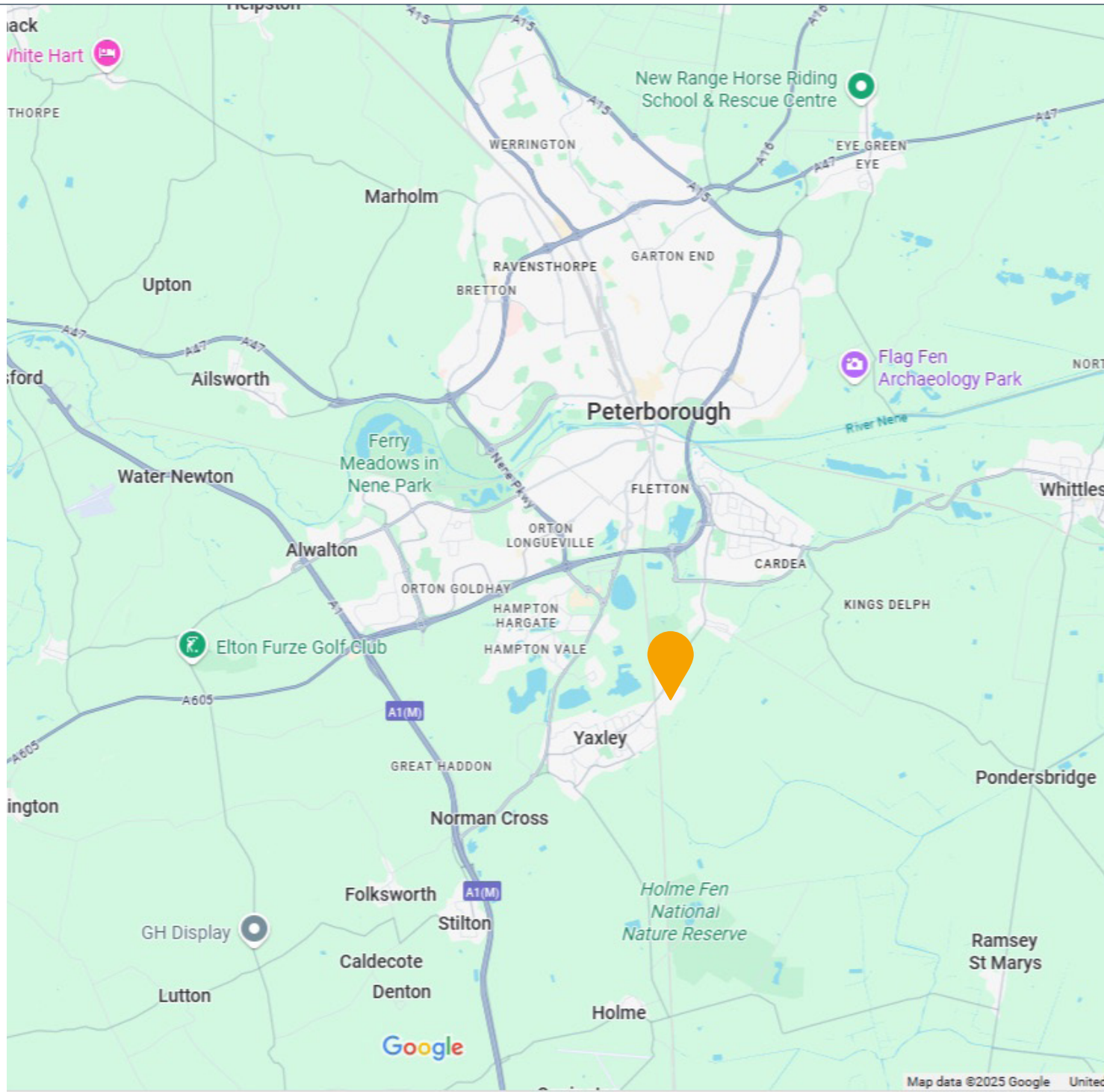
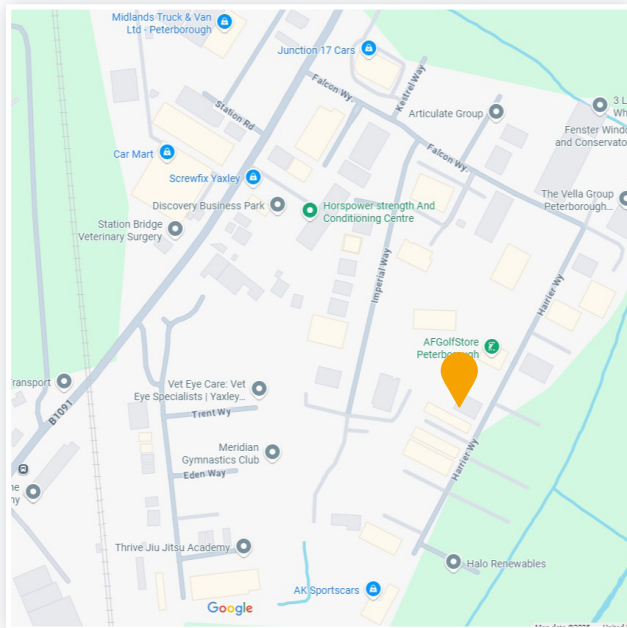
Anti-Money Laundering
