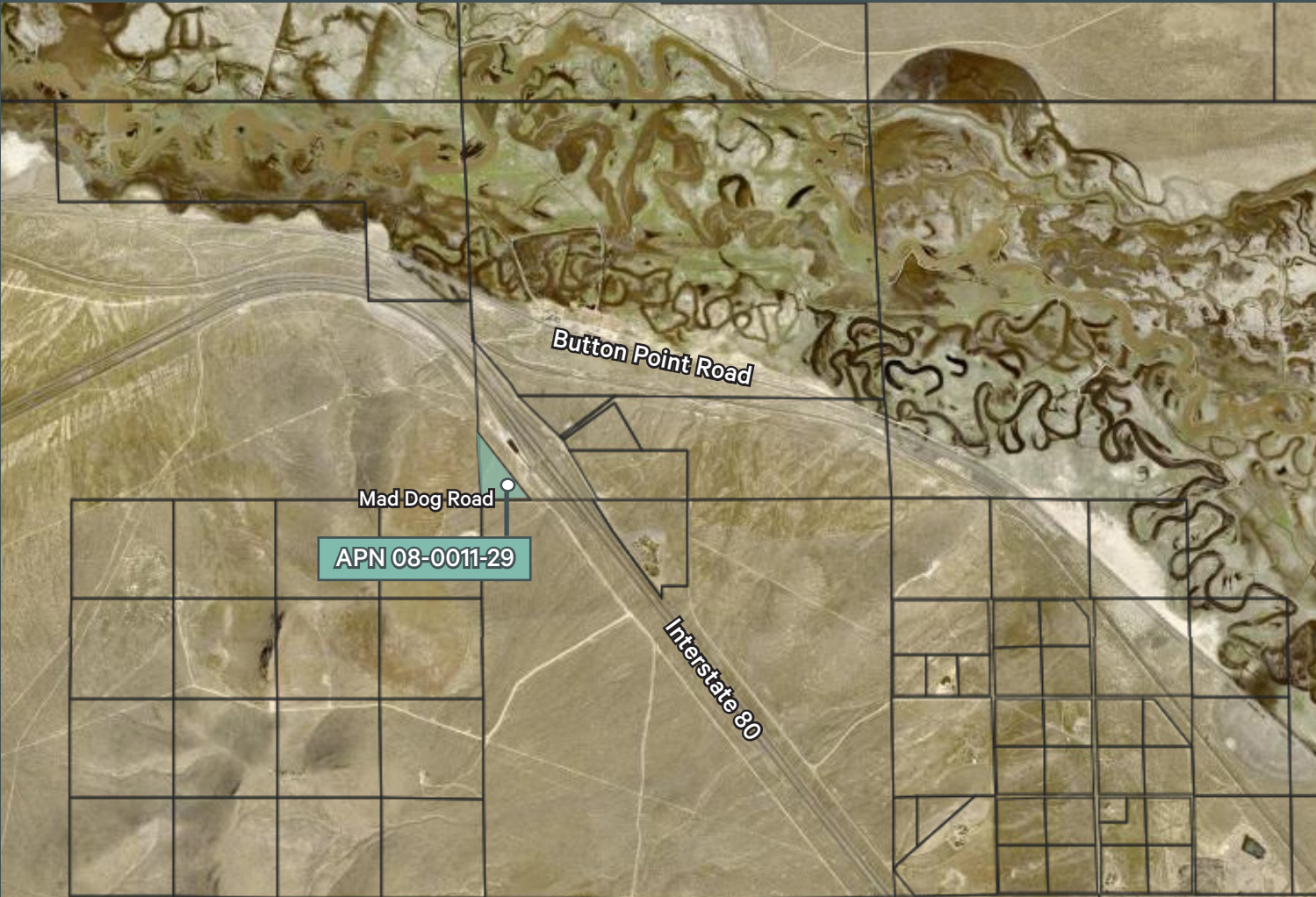

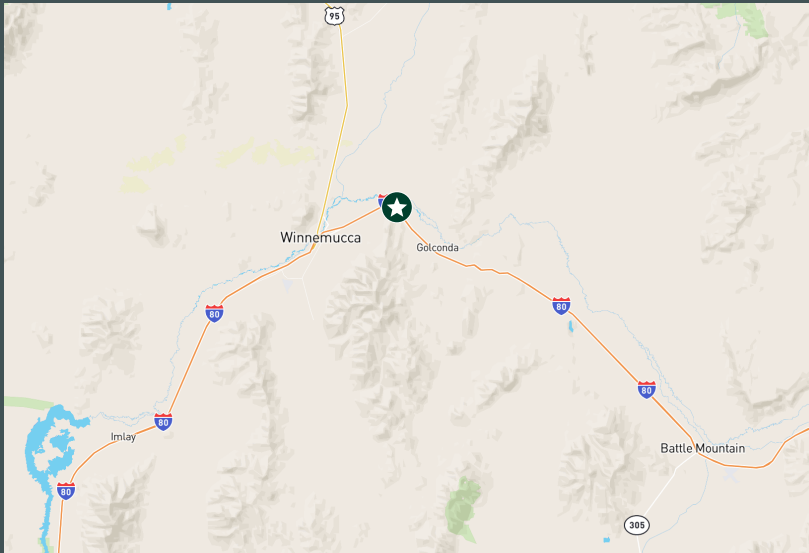

Location

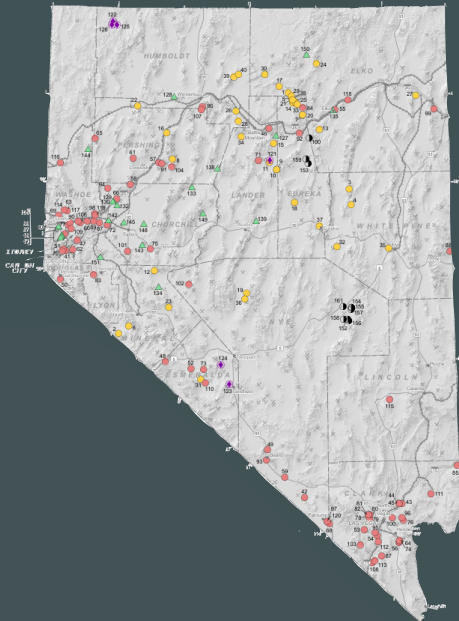


The property is located immediately outside of Winnemucca in Northern Nevada and is annexed to Golconda, Nevada.

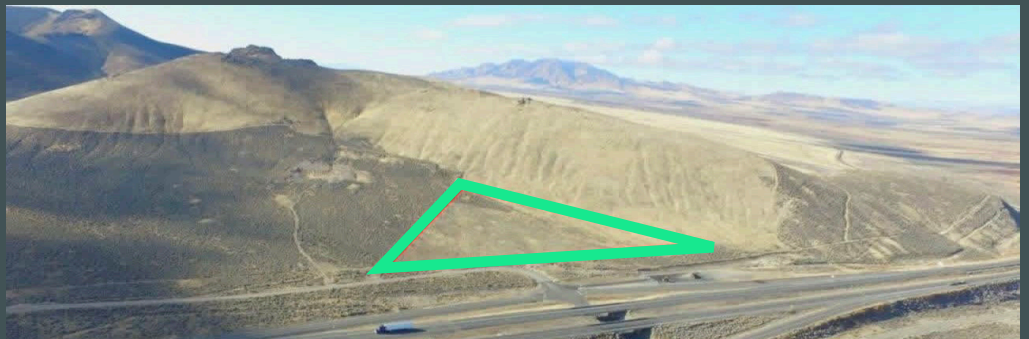
