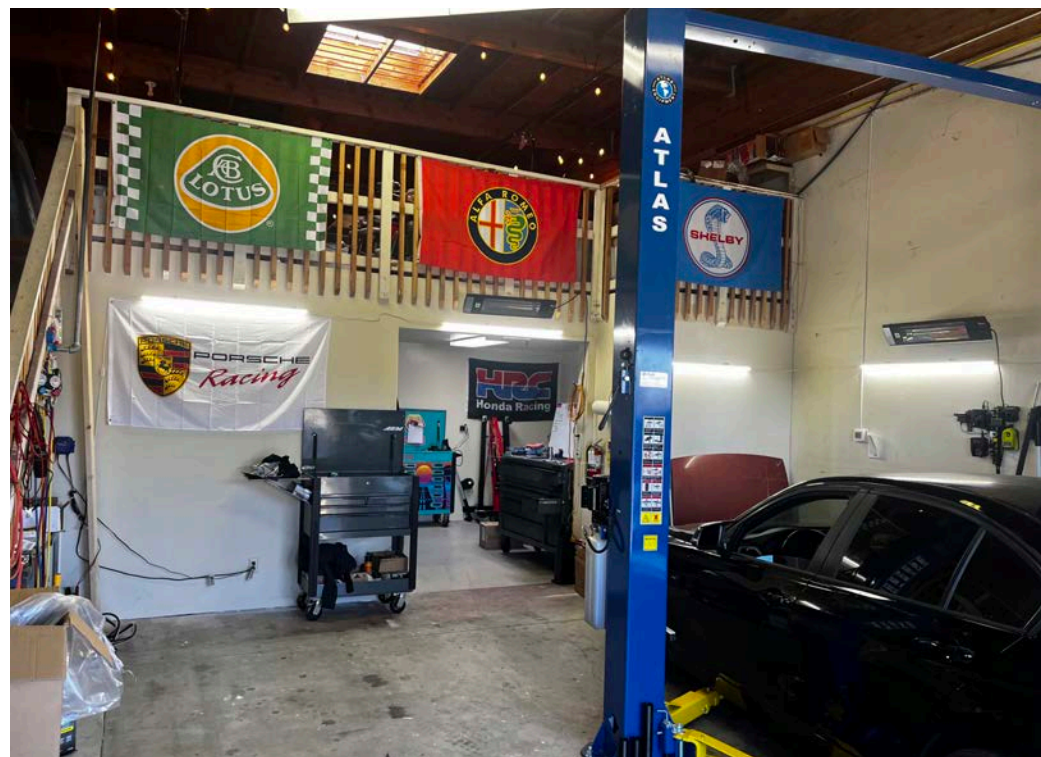
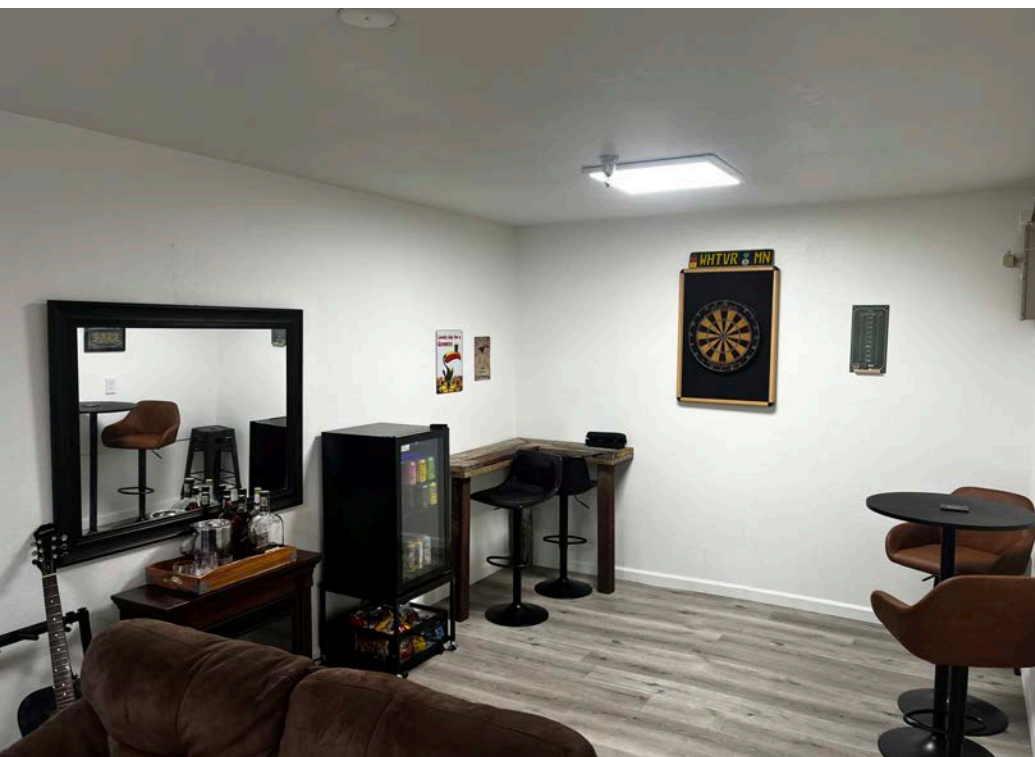

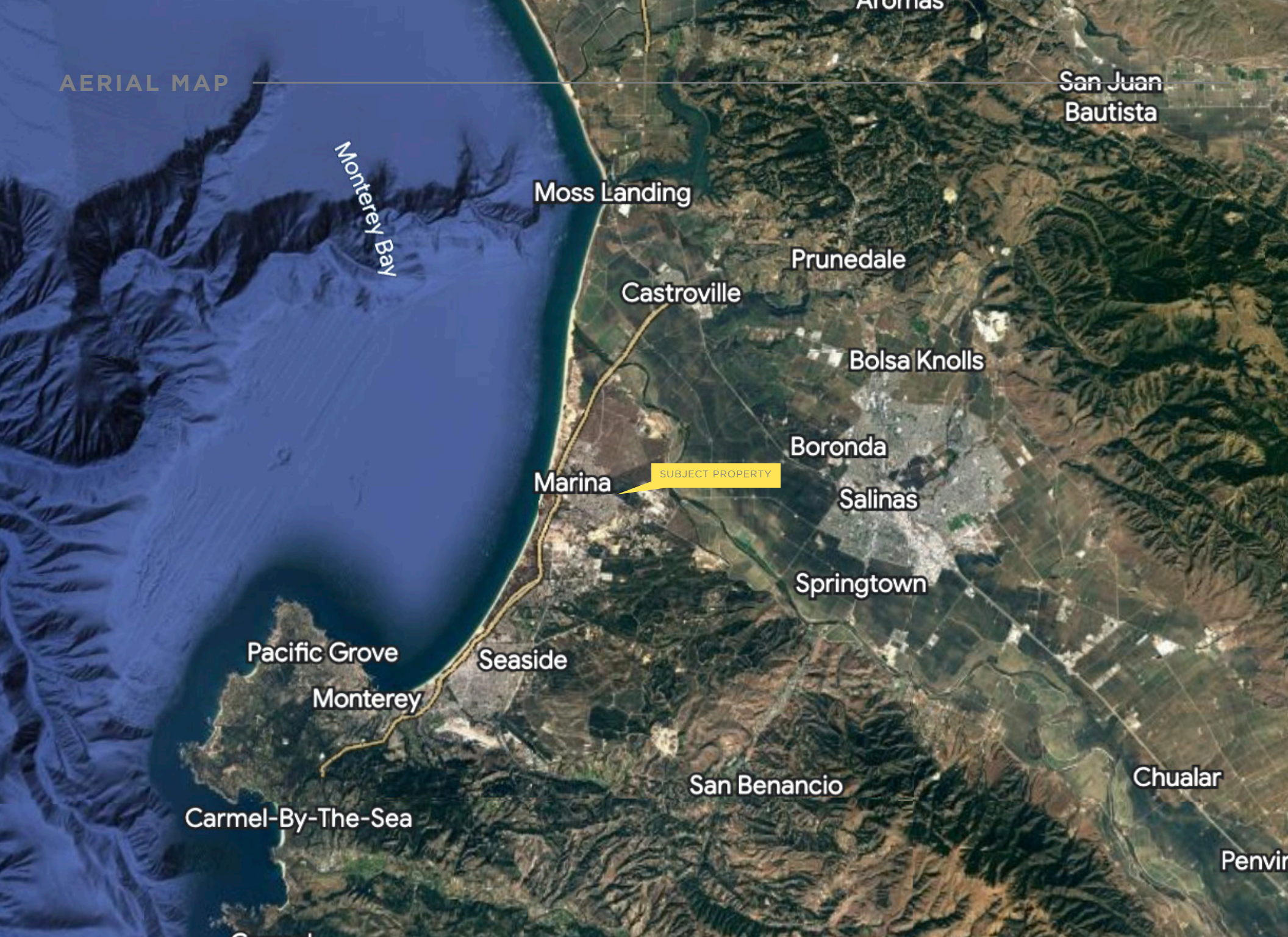




FLOOR PLAN
