LOCATION

Western Campus is located within Strathclyde Business Park which was established in 1990 and is now recognised as Scotland's premier commercial business location. The Park has a wide array of facilities and amenities including a hotel, restaurant, retail parade, children's nursery and gymnasium.

Strathclyde Business Park fronts the A725 Bellshill Bypass which links the M8 and M74 motorways. Glasgow city centre is approximately 14 miles west.

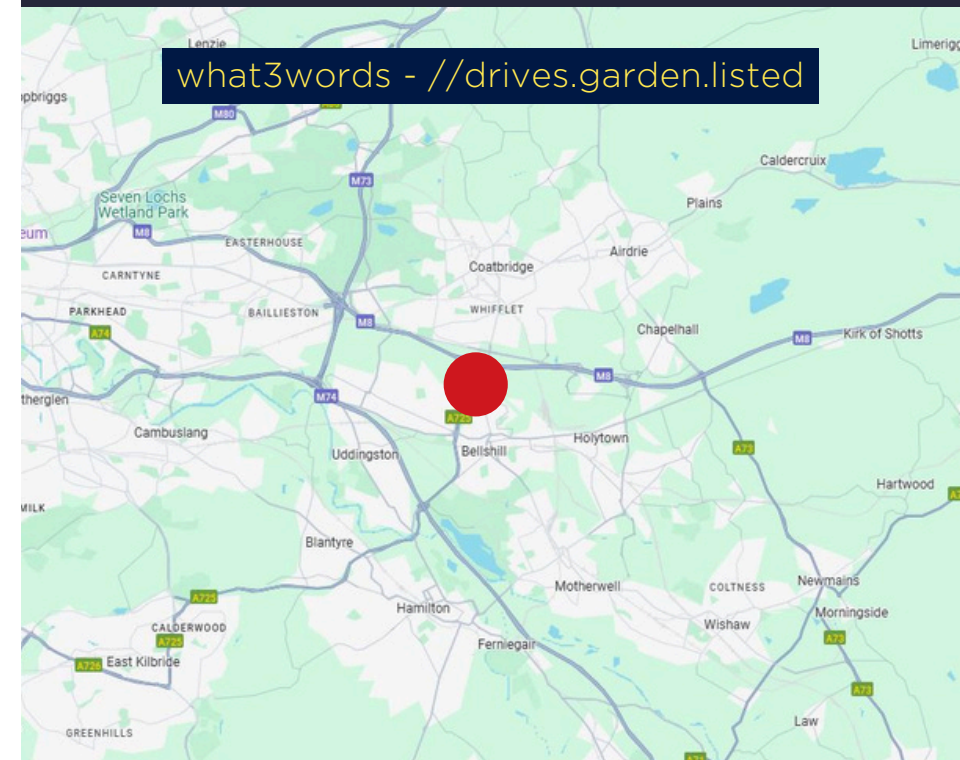
Western Campus is located at the western periphery of the Park at the northern end of Starling Way.
