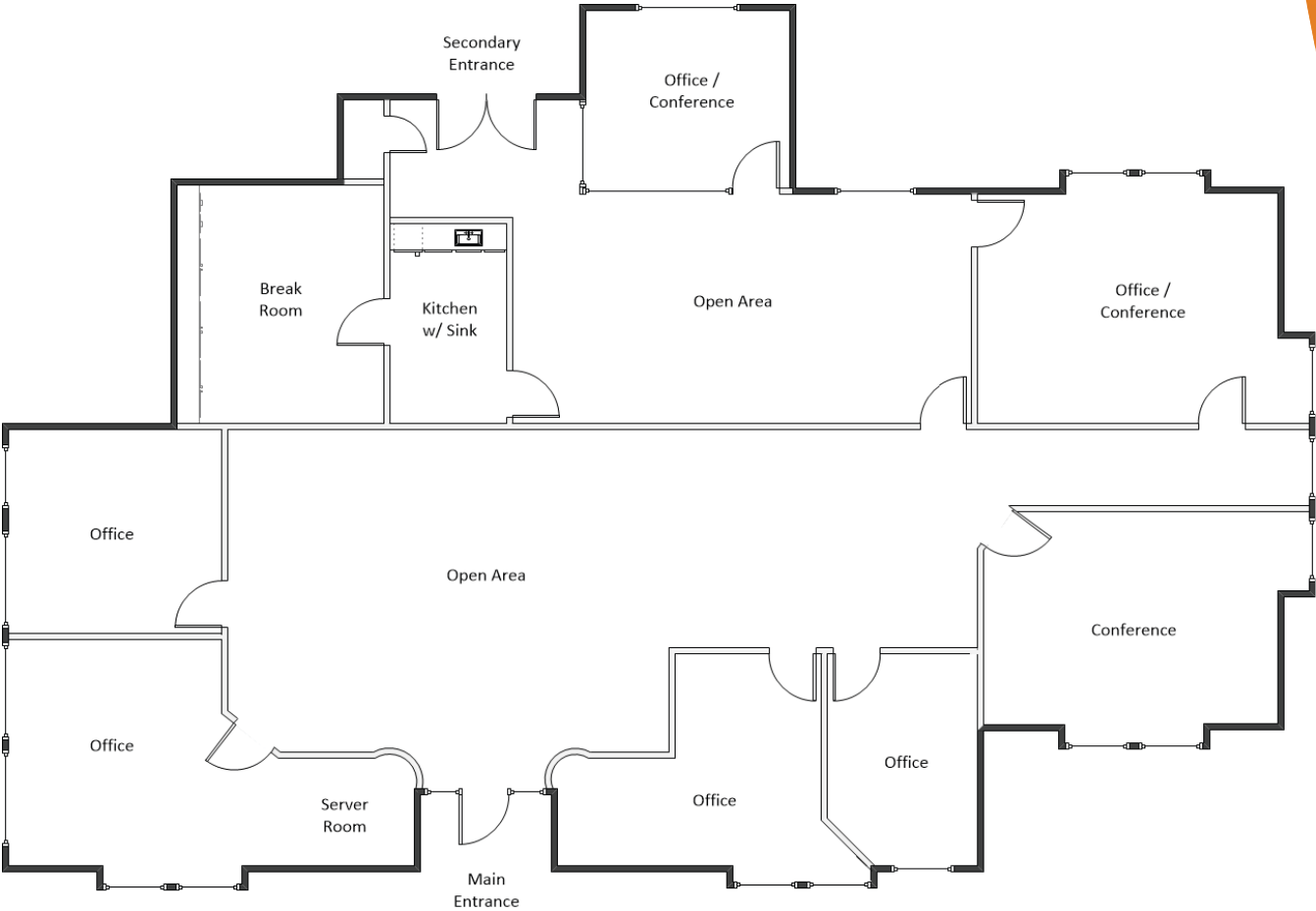

SUITE 1: ±2,788 SF

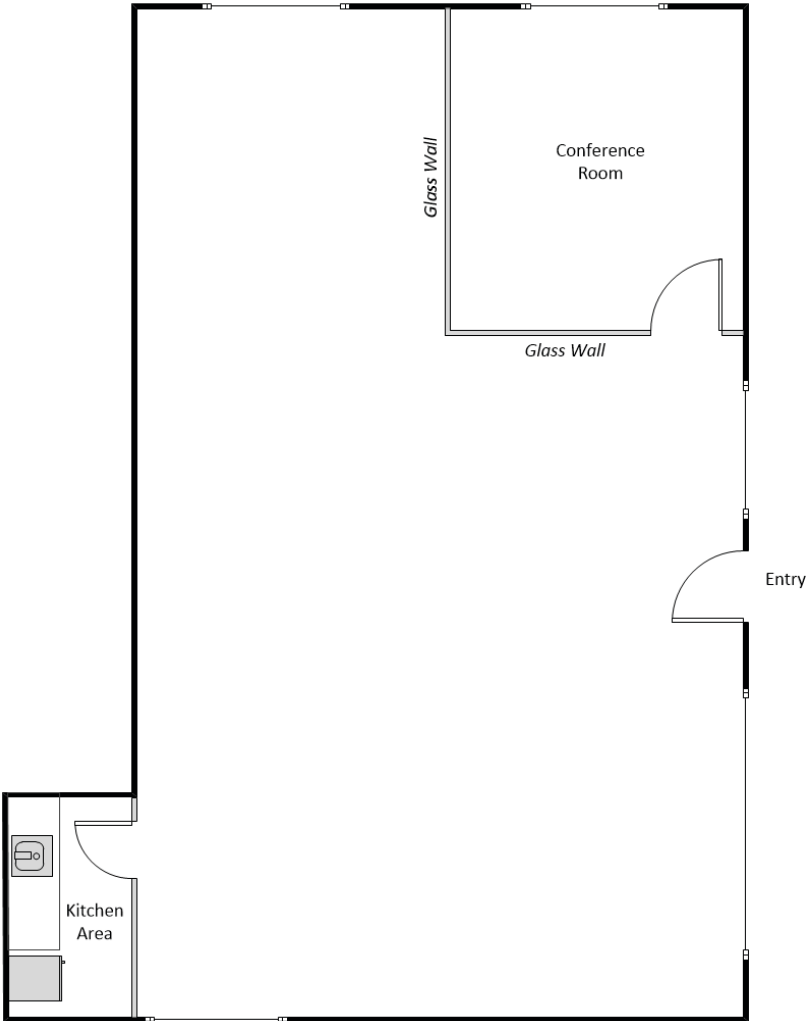

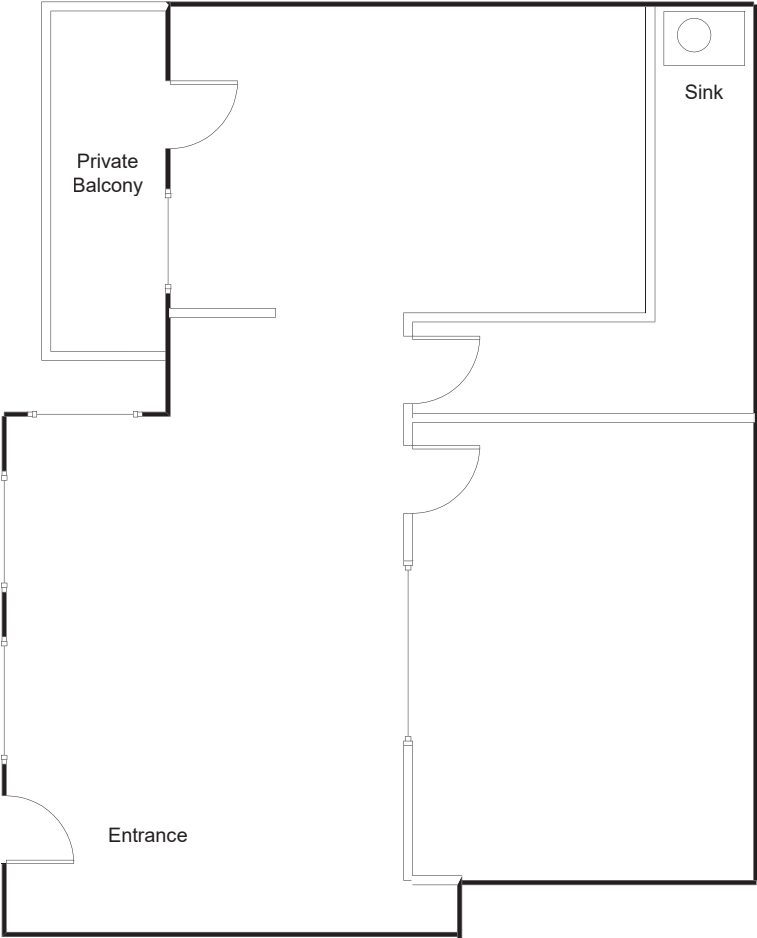

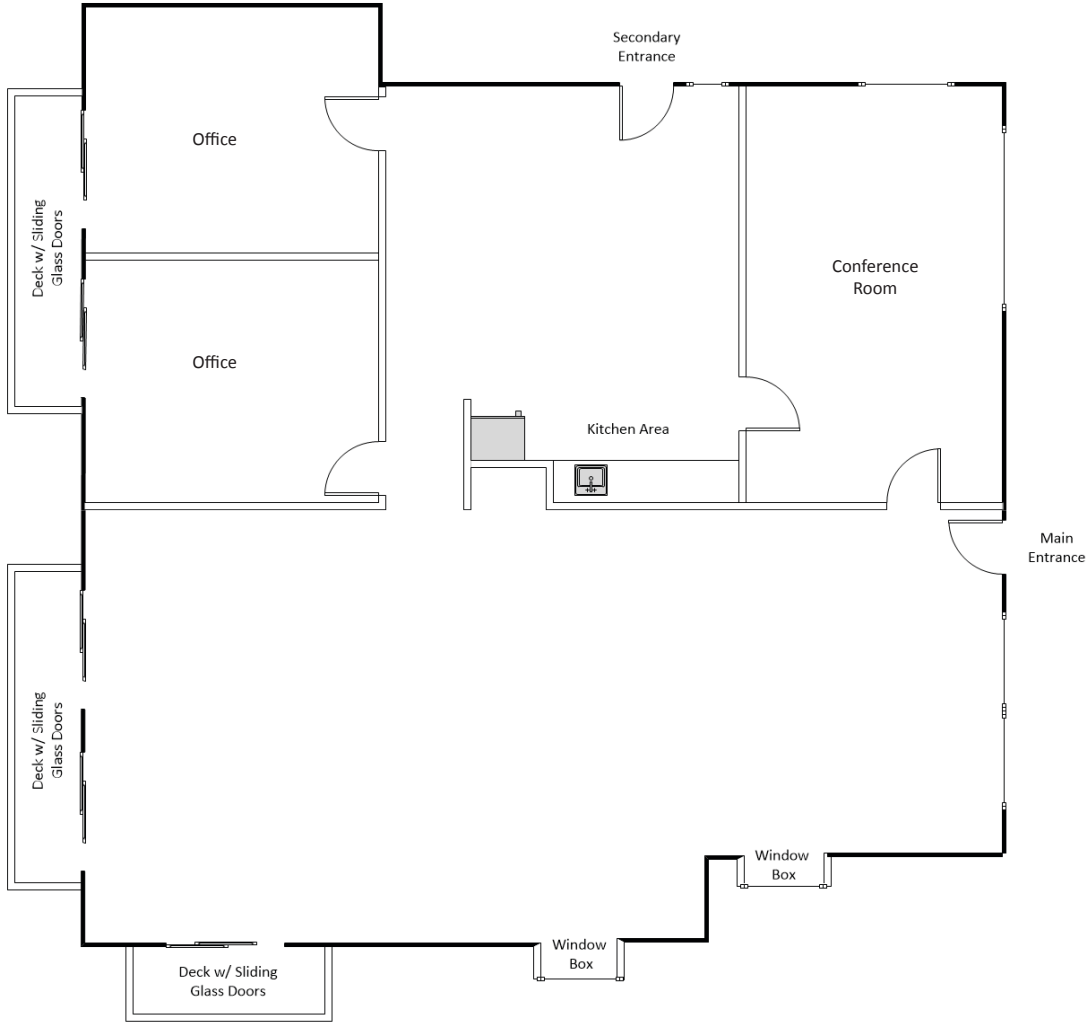

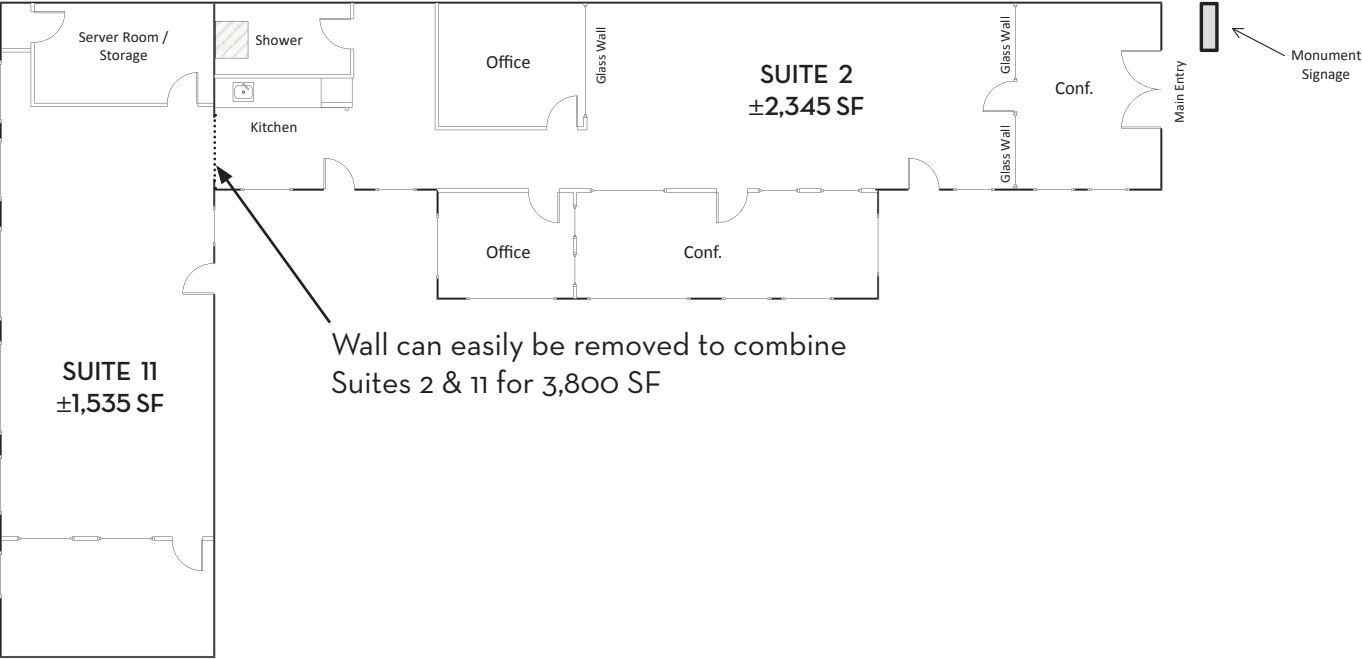
