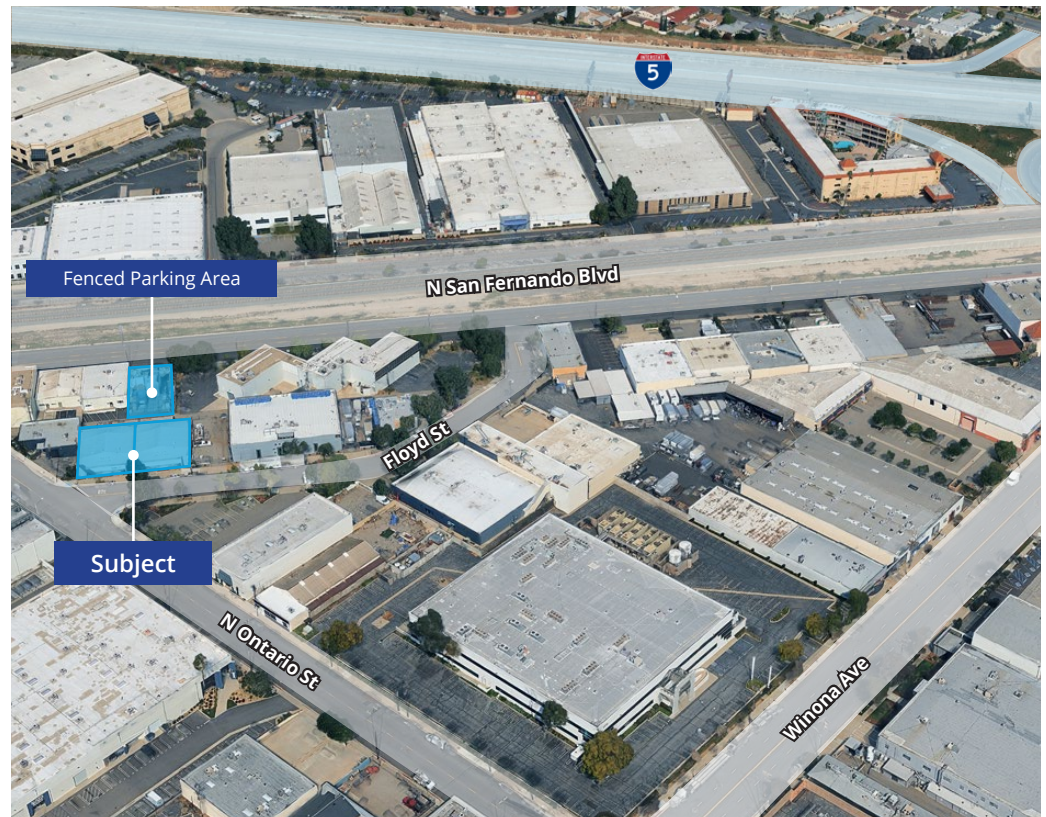

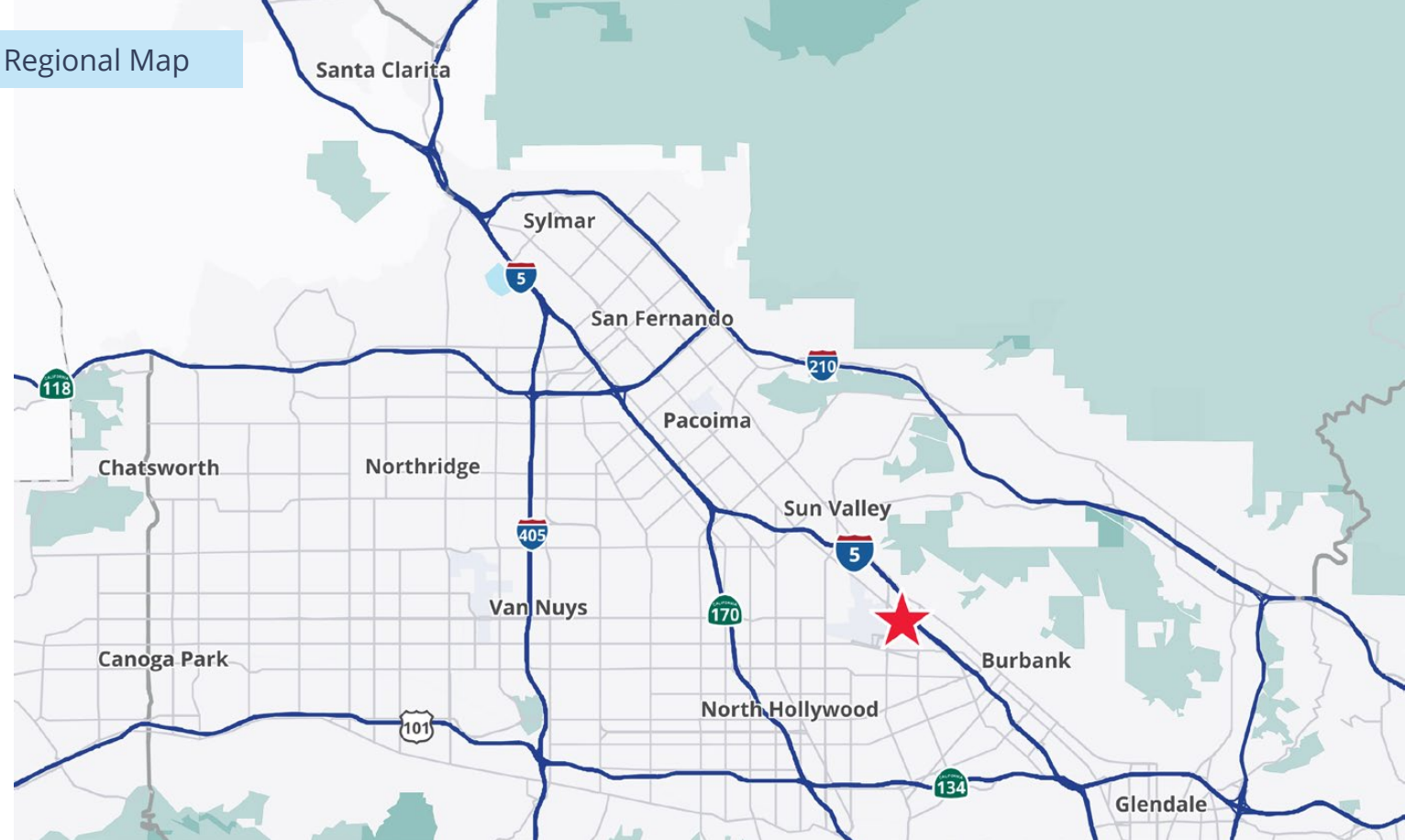

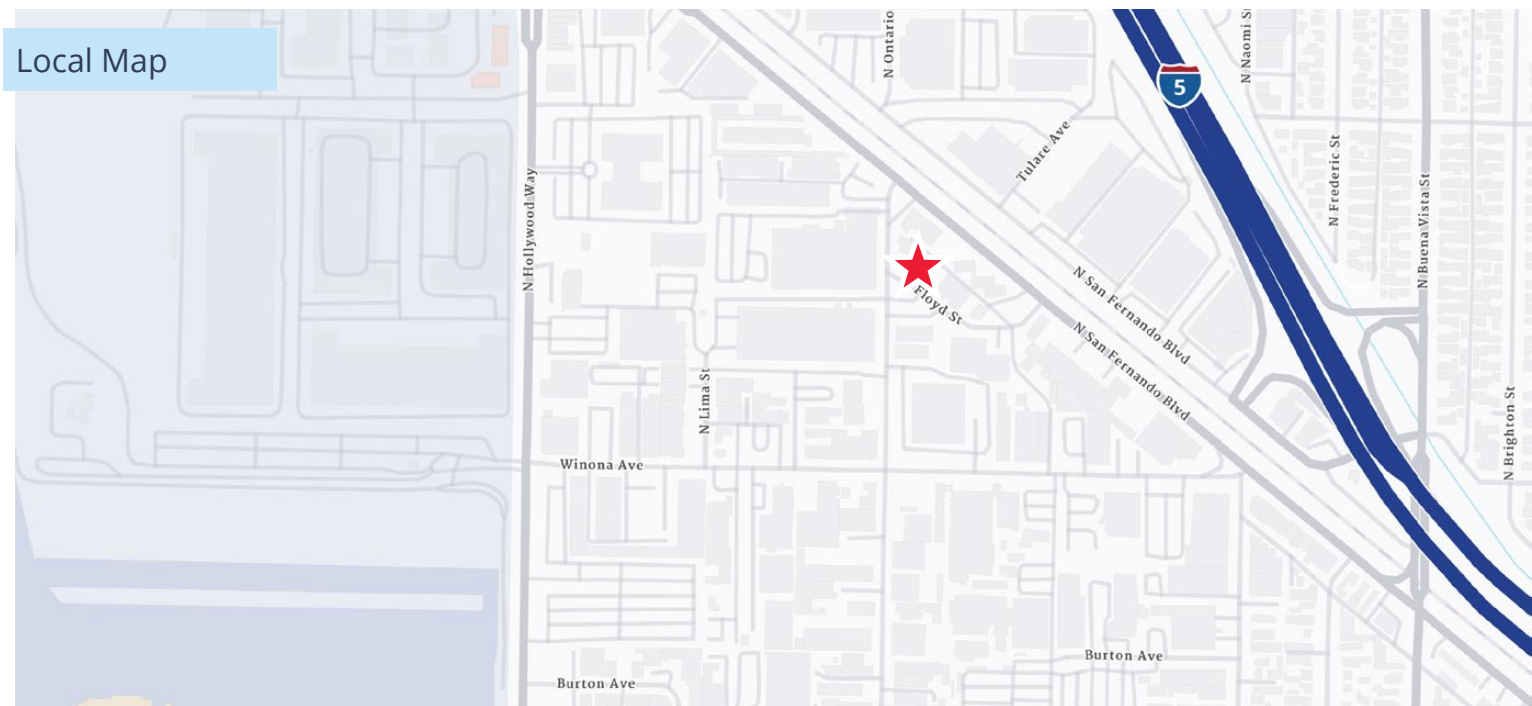


Location Maps
