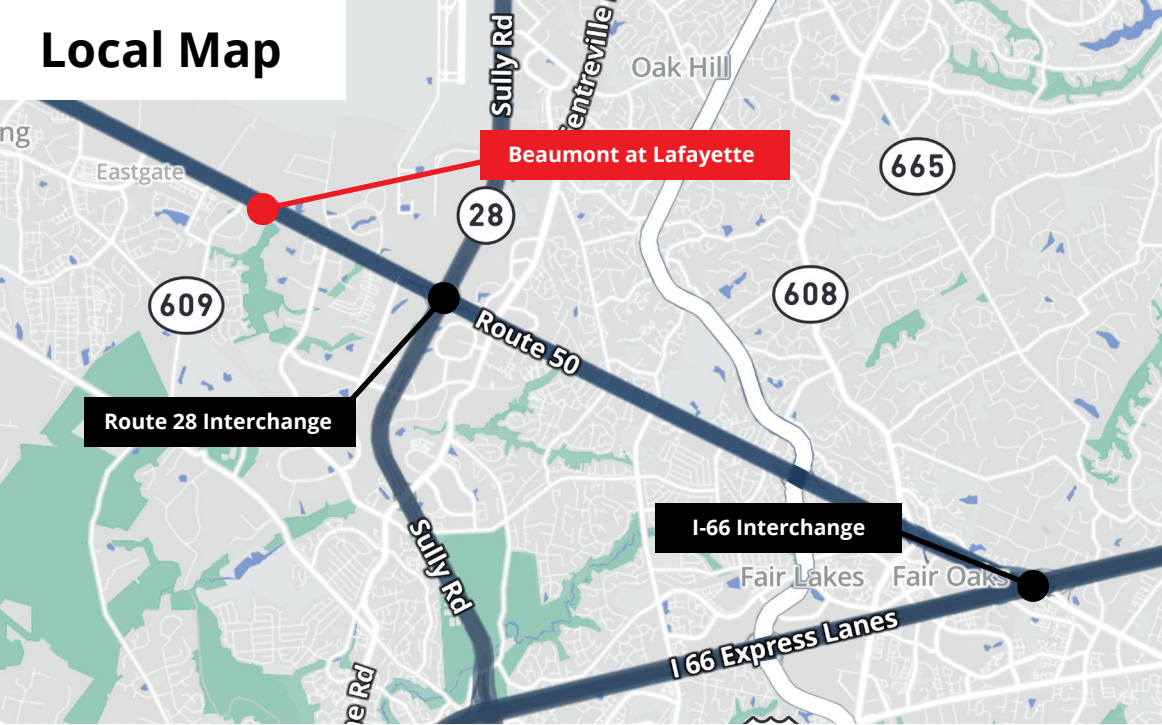

Local Map



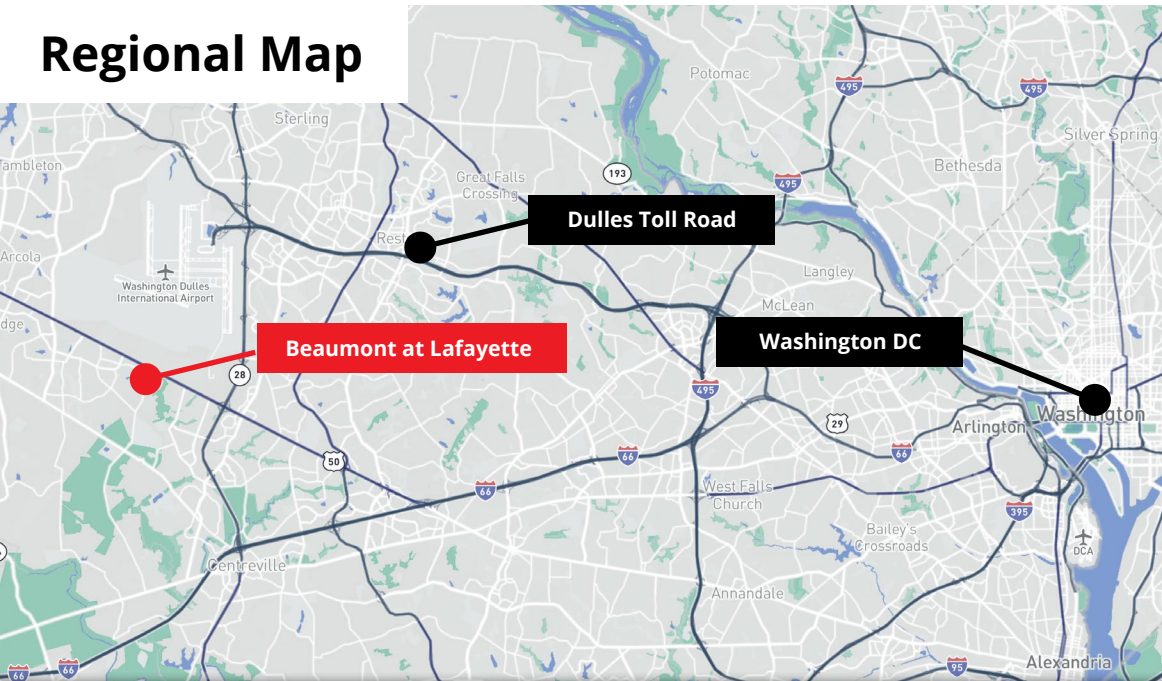

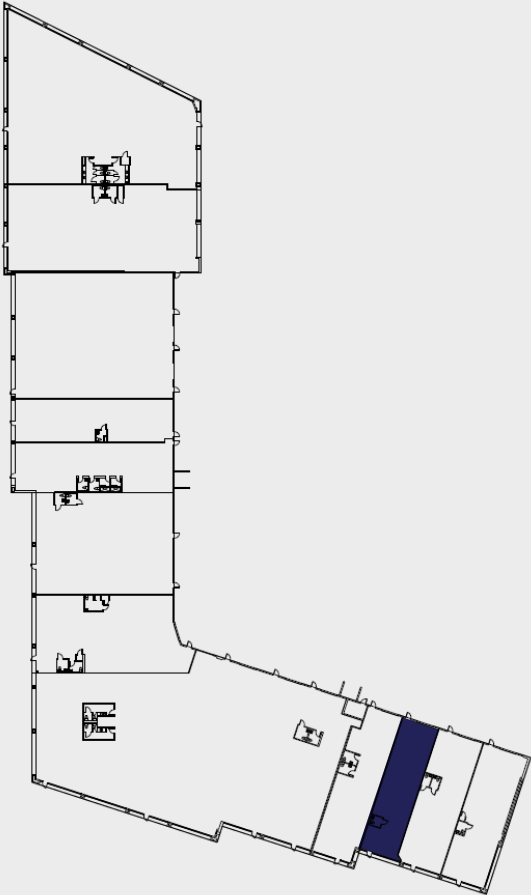

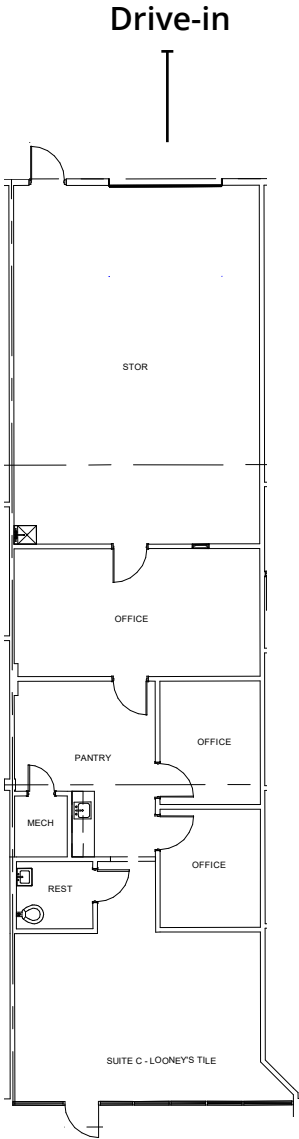

Suite C | 1,894 RSF



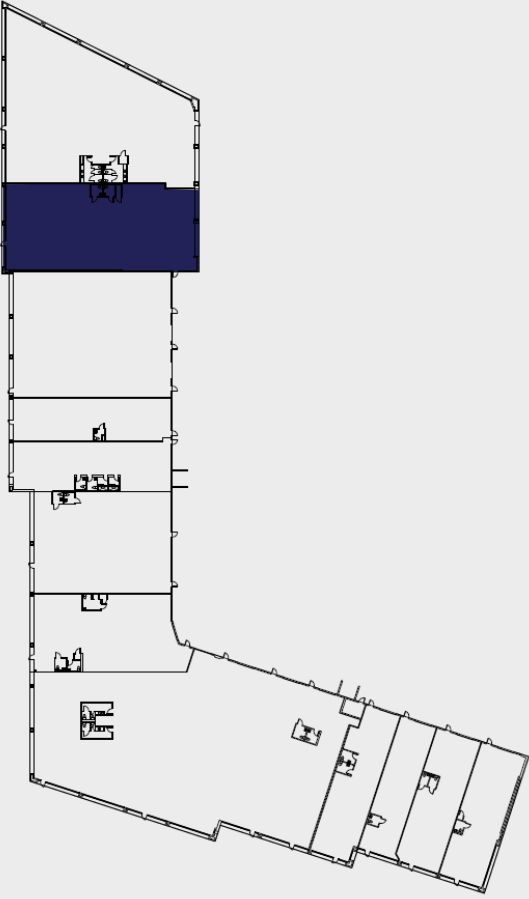
KEY PLAN



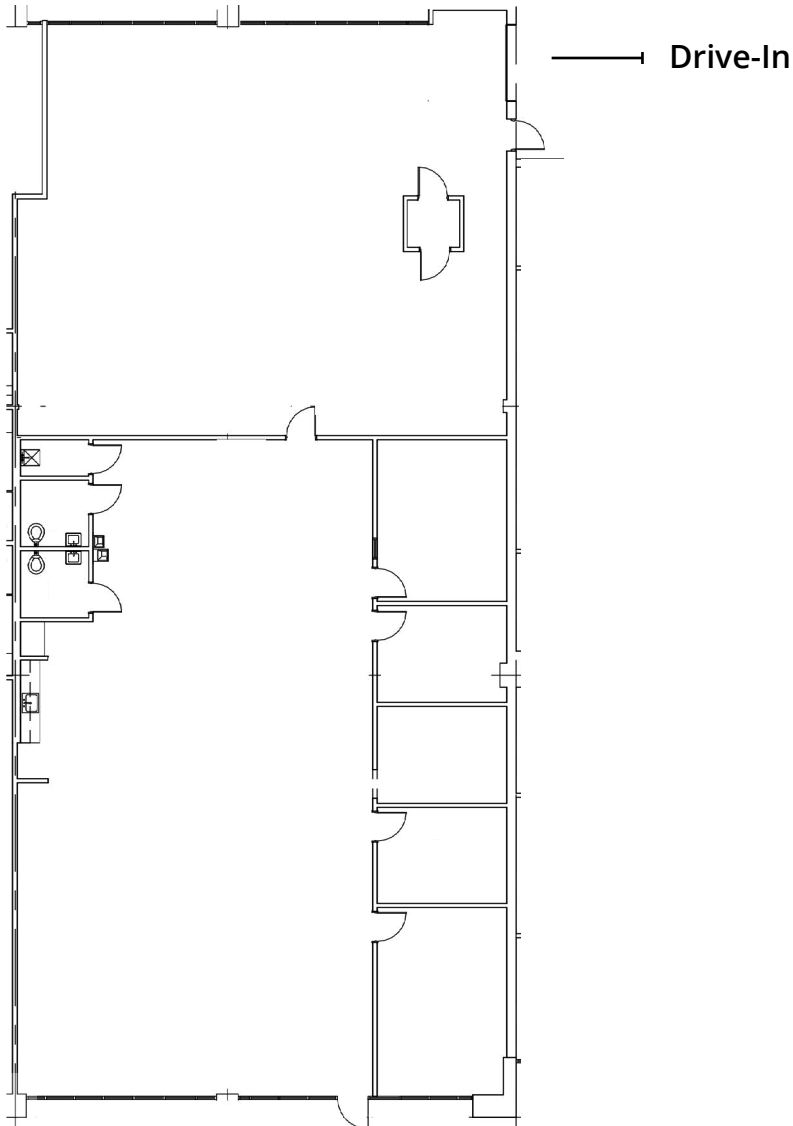
