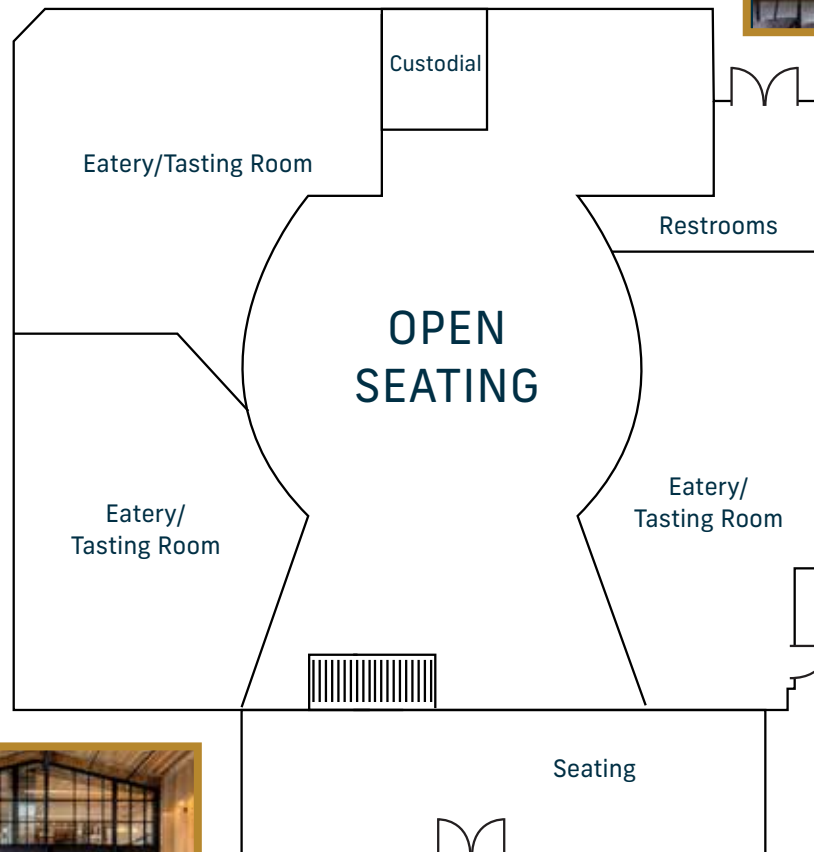

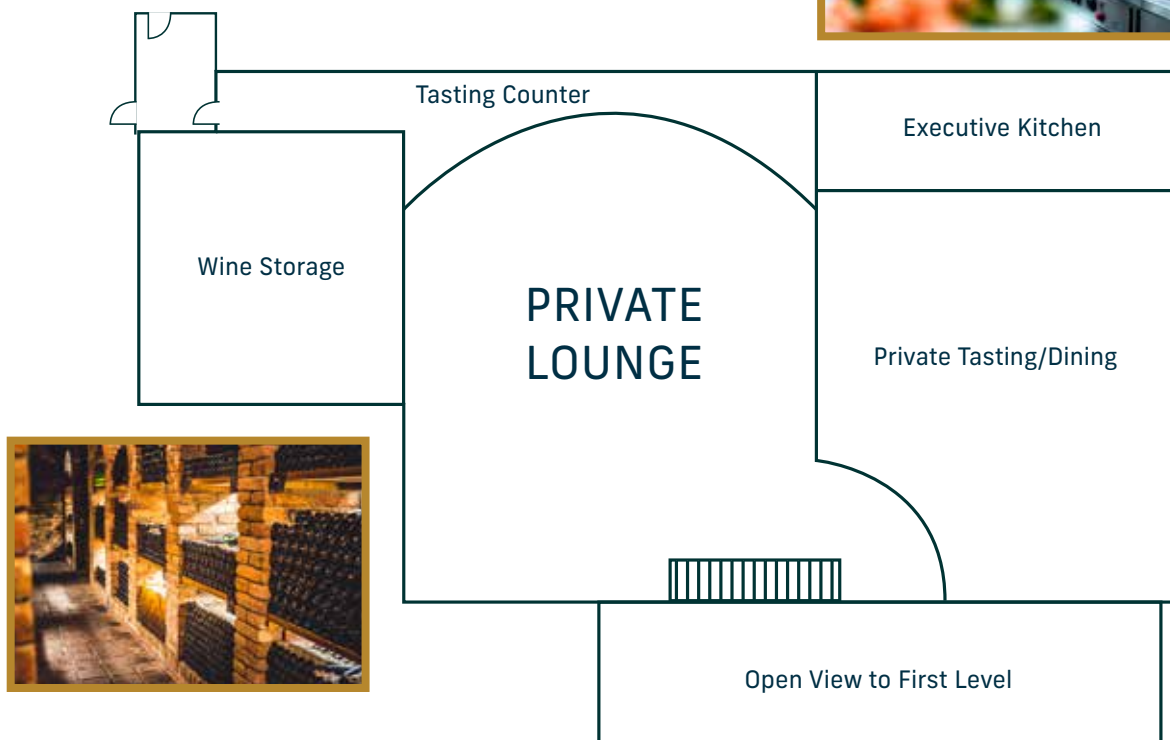
First Level Floor Plan
