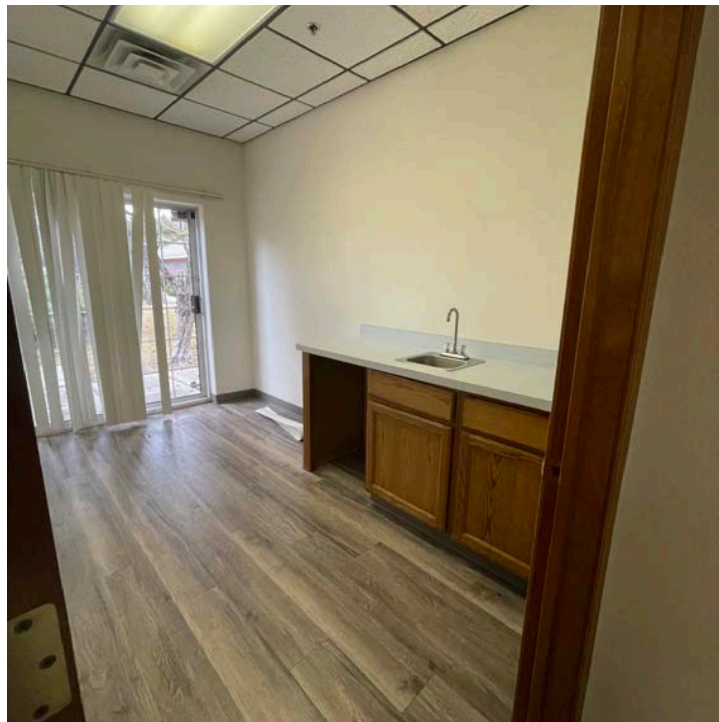
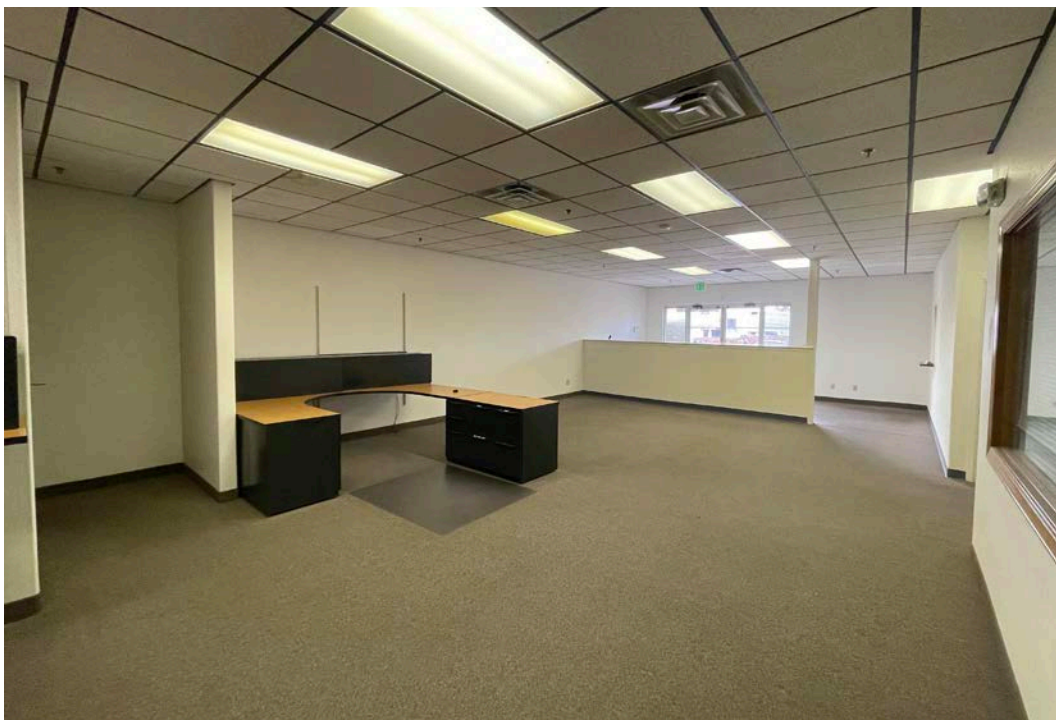


# Building 1311 | Suite 104 – Concept Plan

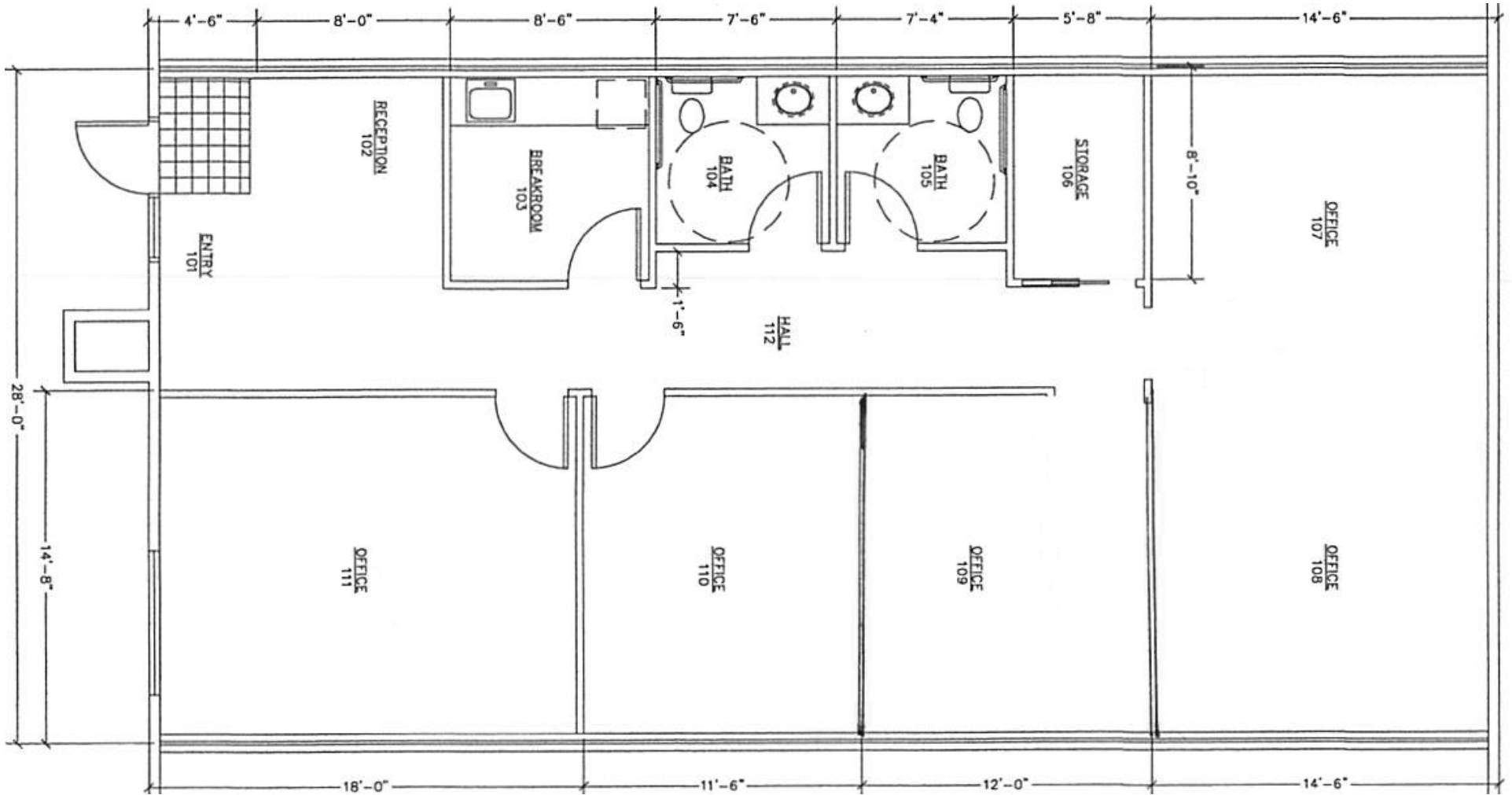
