 NOTIFY ARCHITECT OF DISCREPANCIES PRIOR TO PROCEEDING WITH
- NOTIFY ARCHITECT OF DISCREPANCIES PRIOR TO PROCEEDING V WORK OR AREA IN QUESTION.
- 3. REMOVE ALL ABANDONED CONDUIT, CABLING BACK TO ELECTRICAL/TELEPHONE CLOSET.
- 4. REWORK FIRE LIFE SAFETY ALARM SYSTEM AS REQUIRED FOR NEW WORK.
- 5. APPLIED FIREPROOFING DAMAGED DURING CONSTRUCTION SHALL BE REPAIRED AND PATCHED TO MAINTAIN THE INTEGRITY OF THE BUILDINGS EXISTING FIREPROOFING.



- PARTITION HEAD AND BASE DETAILS. PROVIDE LVL 4 FINISH AT ALL GYP BD SURFACES, U.O.N. LVL 5 AT
- CONFERENCE ROOMS, MEETING ROOMS AND PRIVATE OFFICES. USE 5/8" TYPE 'X' GYP. BD. THROUGHOUT. U.O.N.
