PROPERTY

Houston County Galleria is a 480,808-square-foot regional mall serving the Warner Robins area-one of Georgia's fastest-growing, most economically stable markets. The center sits at a high-visibility intersection along Watson Boulevard, a major retail corridor with over 60,000 vehicles daily and more than 110,000 residents within five miles.

The Galleria is 94% occupied and features over 60 national and regional retailers, including Belk, JCPenney, Crunch Fitness, Big Air Trampoline Park, Bath & Body Works, Victoria's Secret, Finish Line, and Galleria 15 Cinema. Recent redevelopment of the former Sears box and a new 156-unit luxury multifamily project on site further strengthen the property's long-term appeal.

Positioned in a thriving trade area anchored by Robins Air Force Base and the Museum of Aviation, Houston County Galleria remains the region's premier shopping and entertainment destination.

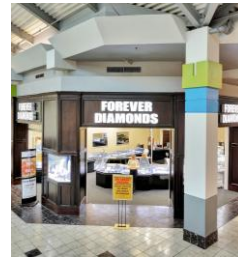

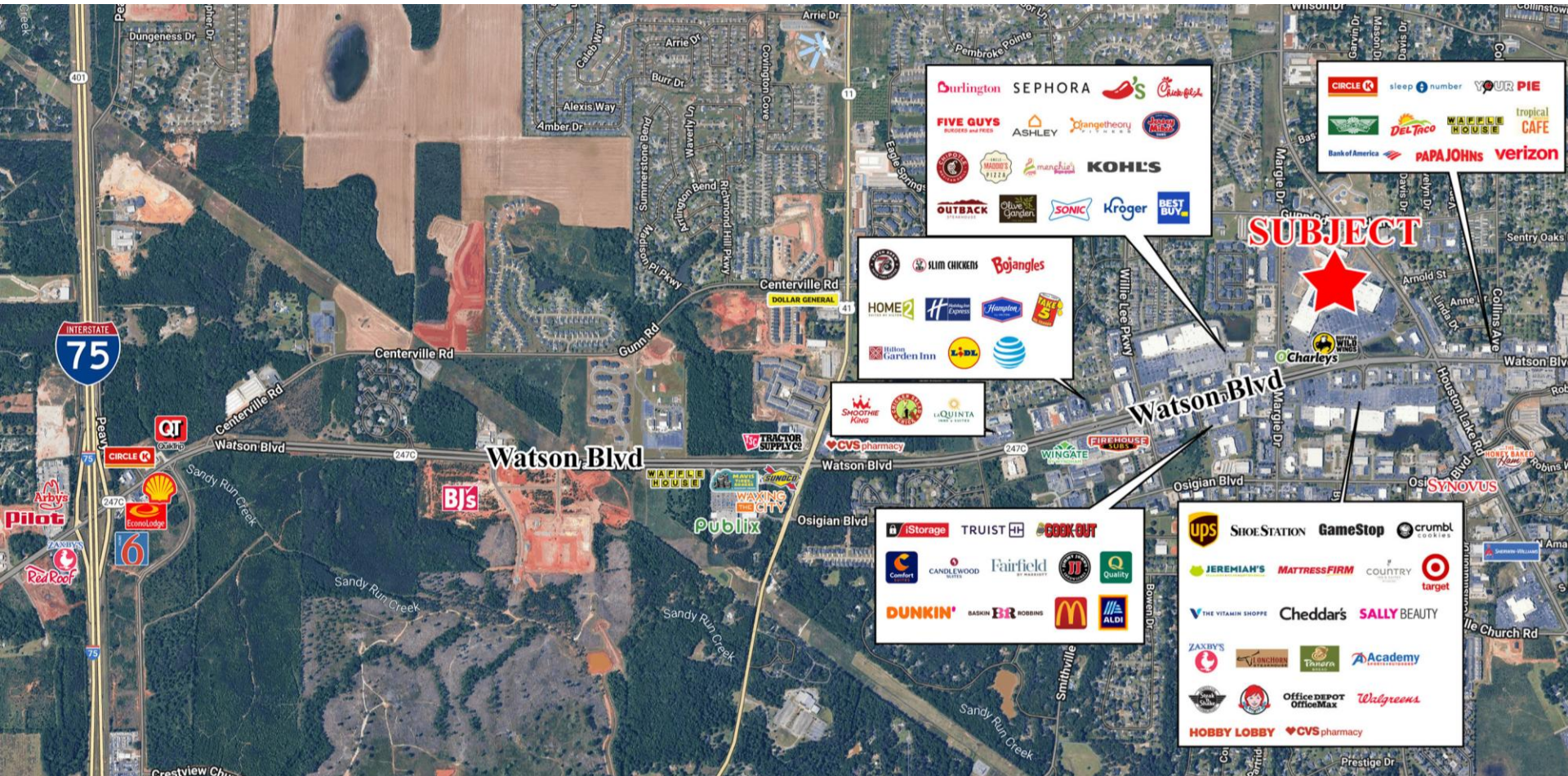

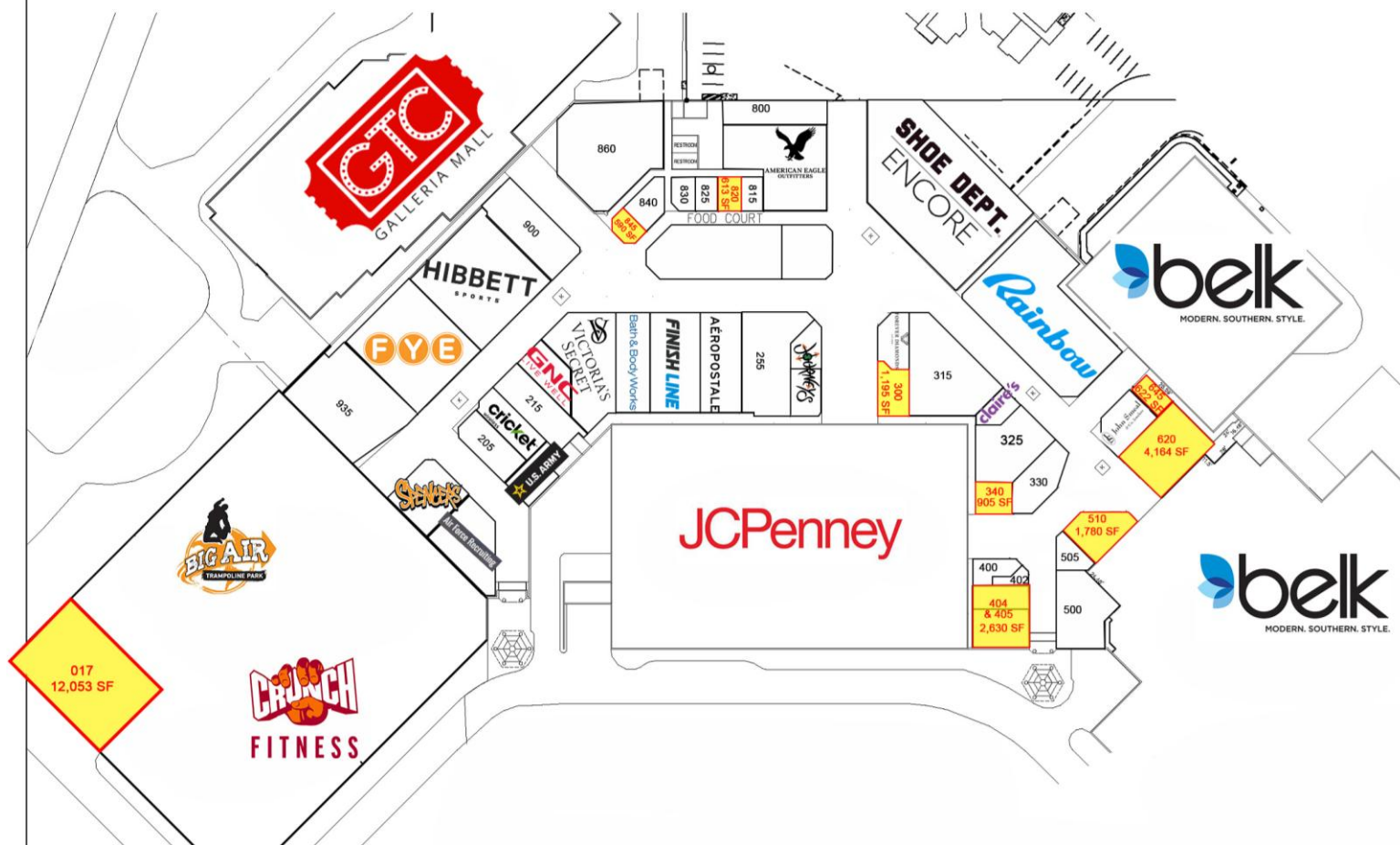
