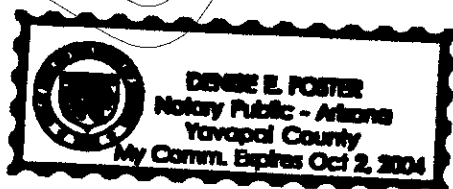

PARCEL B:
