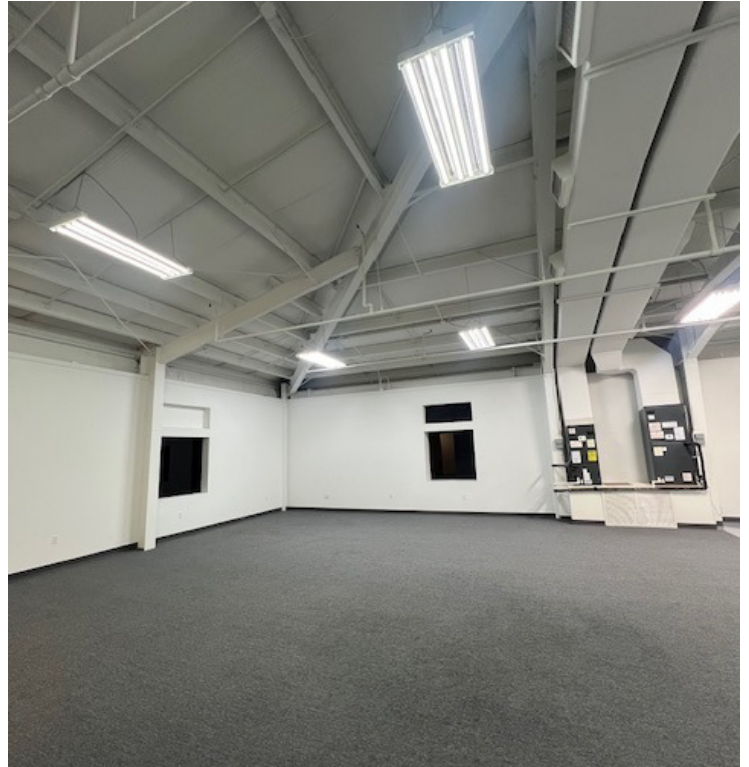

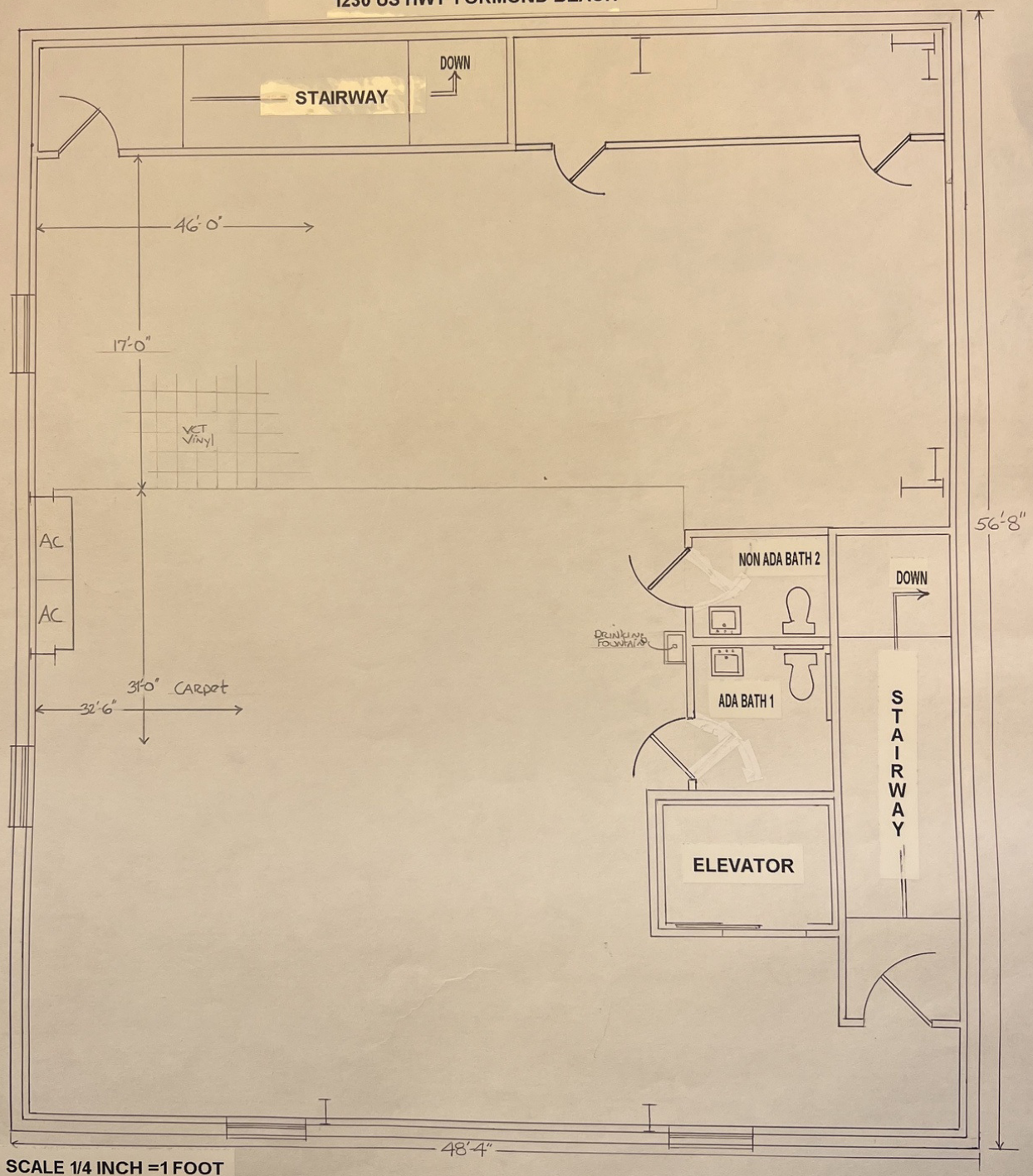

1230 US HWY 1 ORMOND BEACH

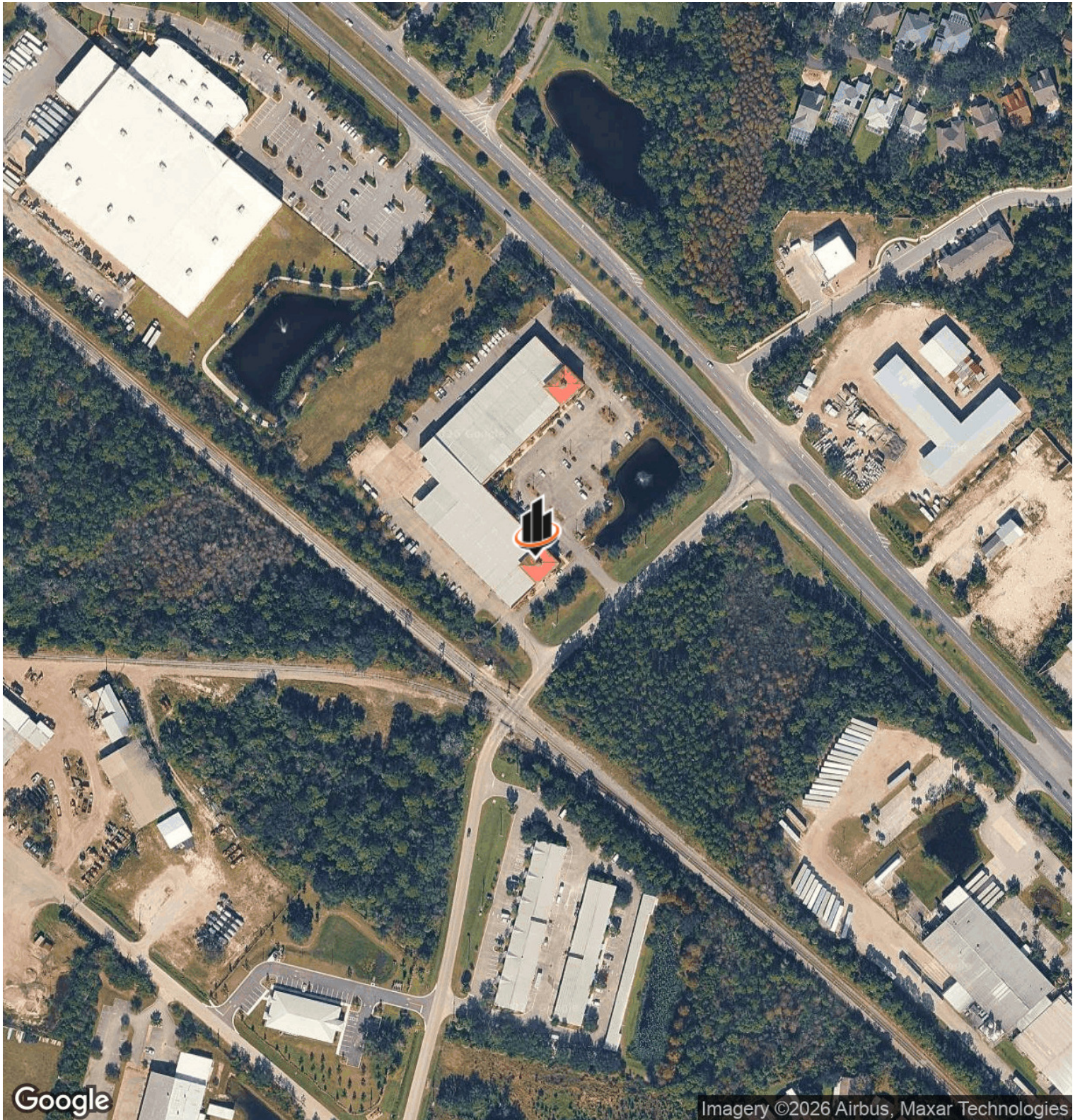
SUITE 30 FLOOR 3
