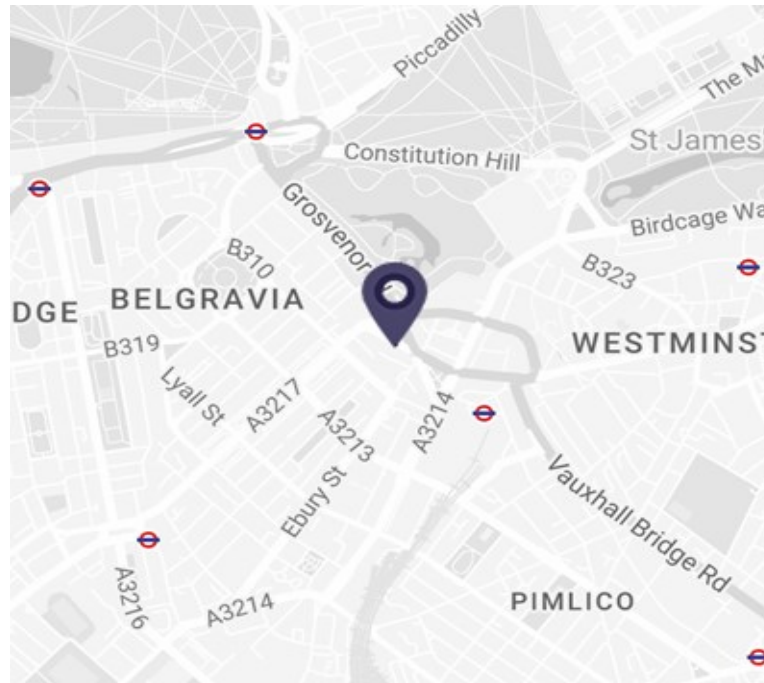






Location
