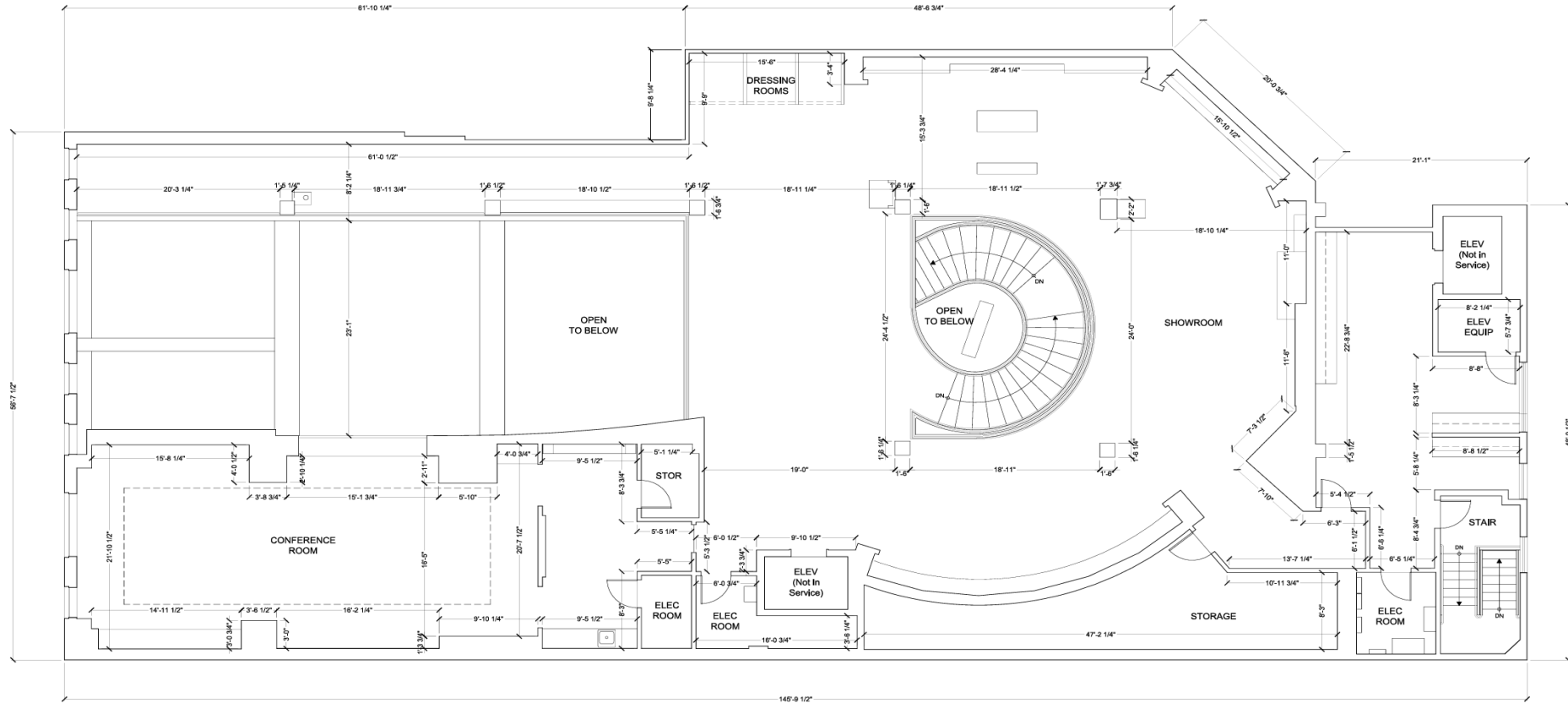




Verizon Floor Plan – Ground Floor

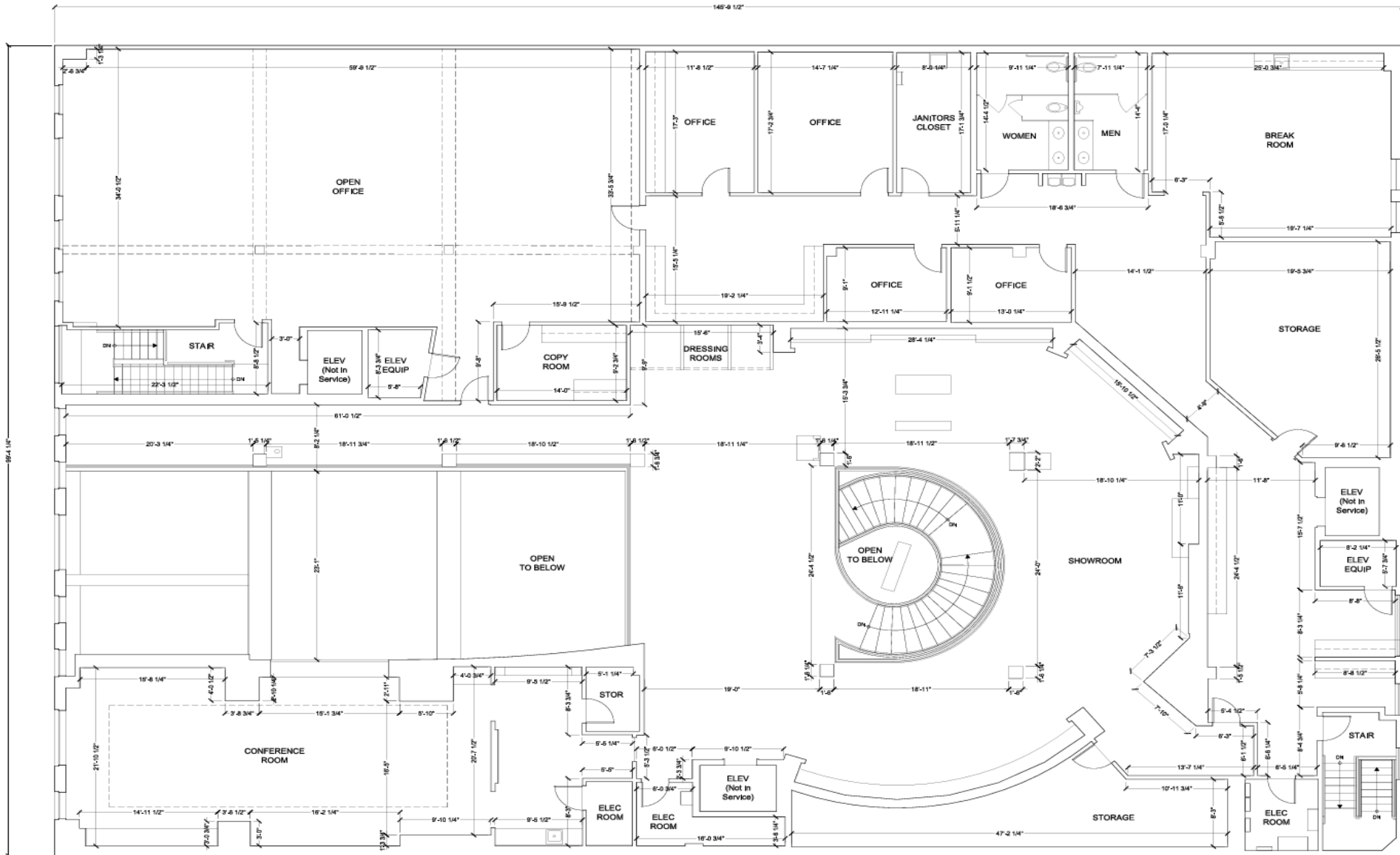


PARTIAL 2nd Floor – Floor Plan



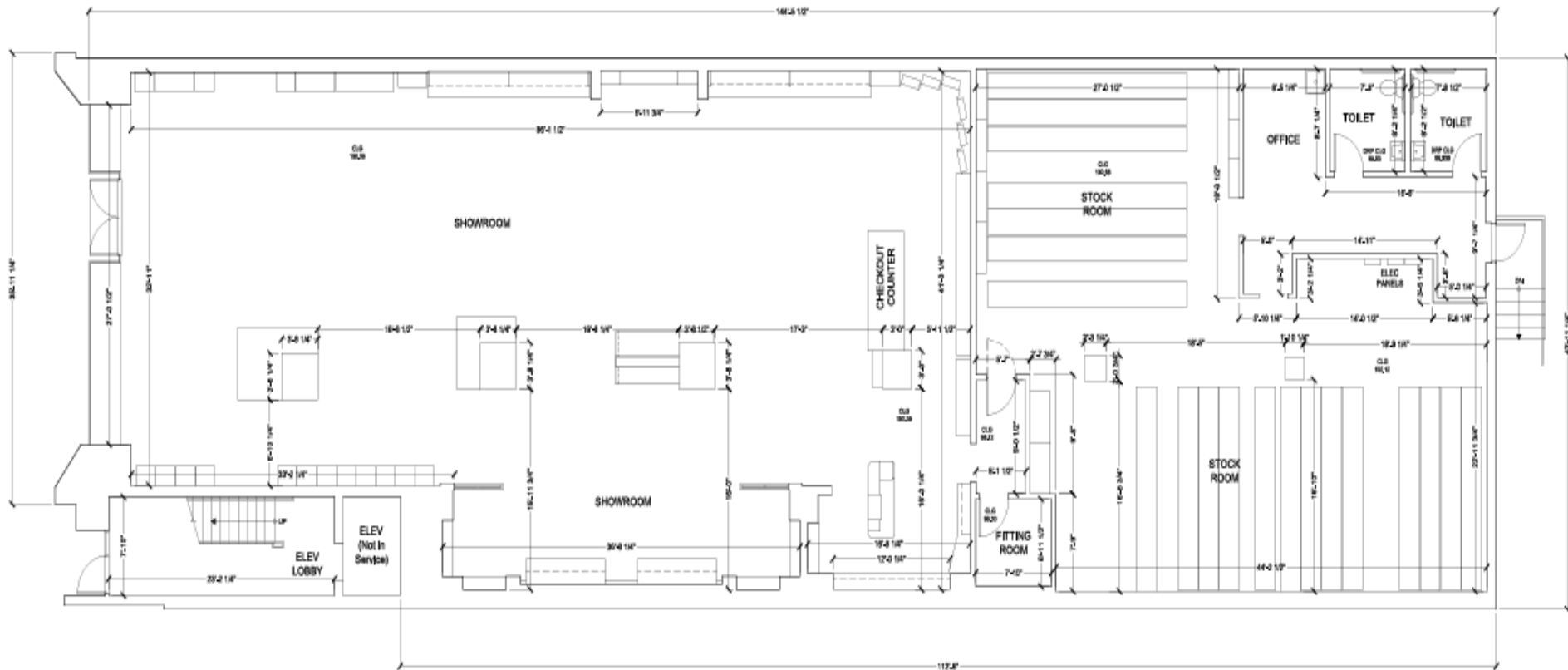
