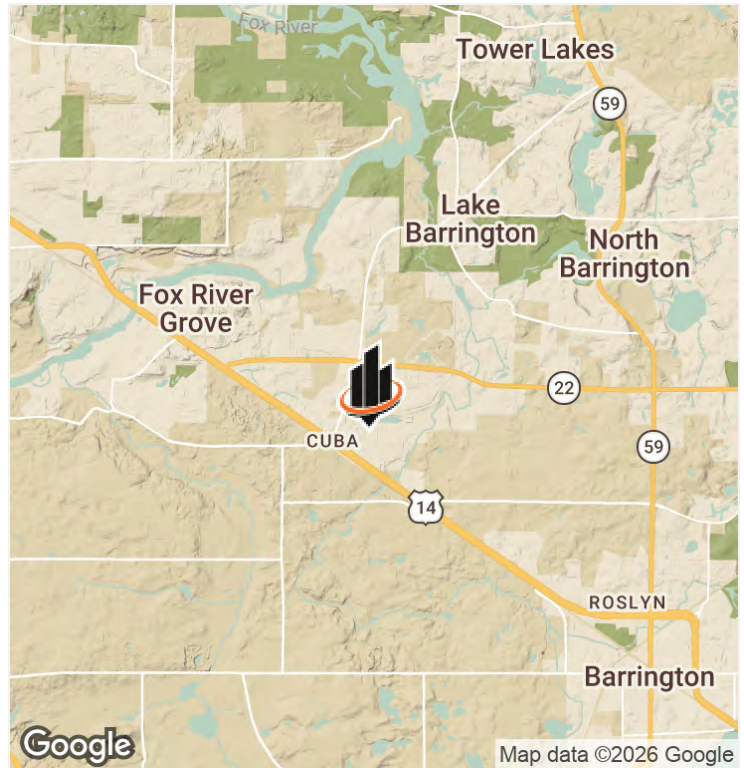

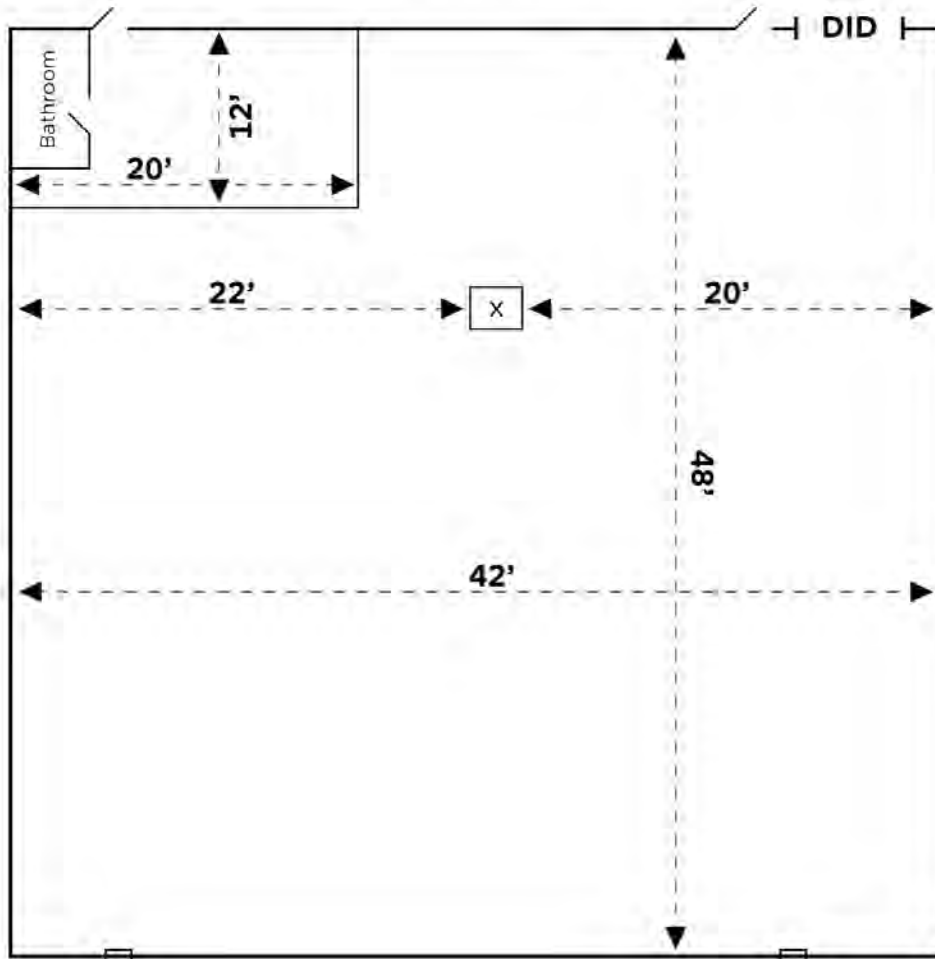

FLOOR PLANS

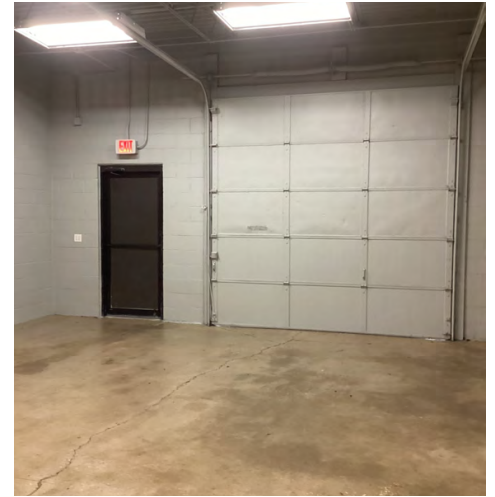
