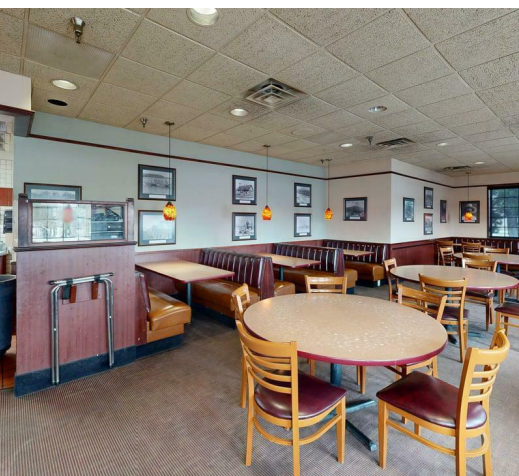

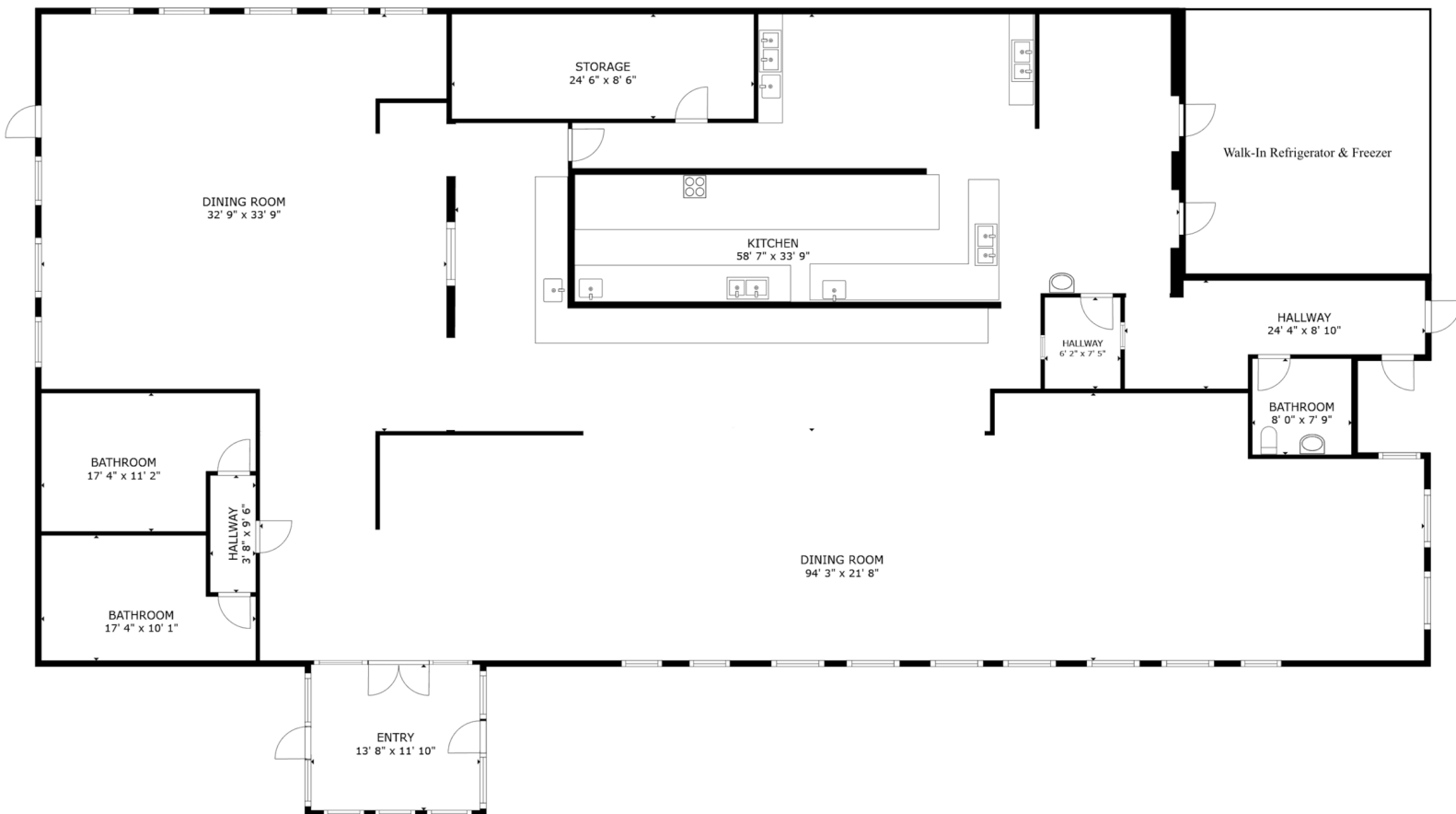

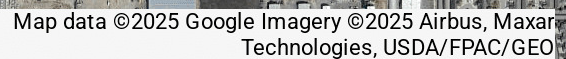
FLOOR PLAN
