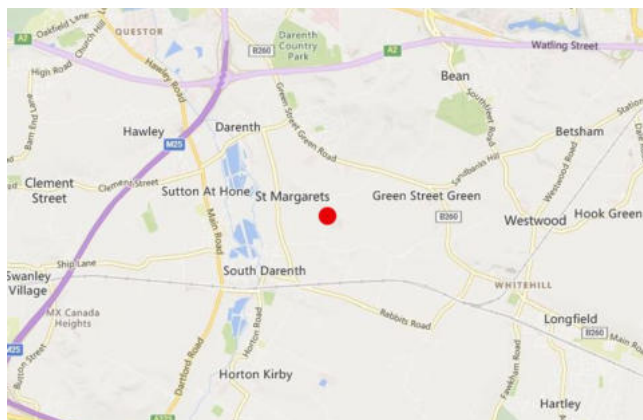

Location

The Ebbsfleet International Passenger Station on the high speed rail link lies immediately to the east of St Margaret's providing swift access (18 minutes) to London St. Pancras.

The Bluewater Shopping Centre is also nearby.
