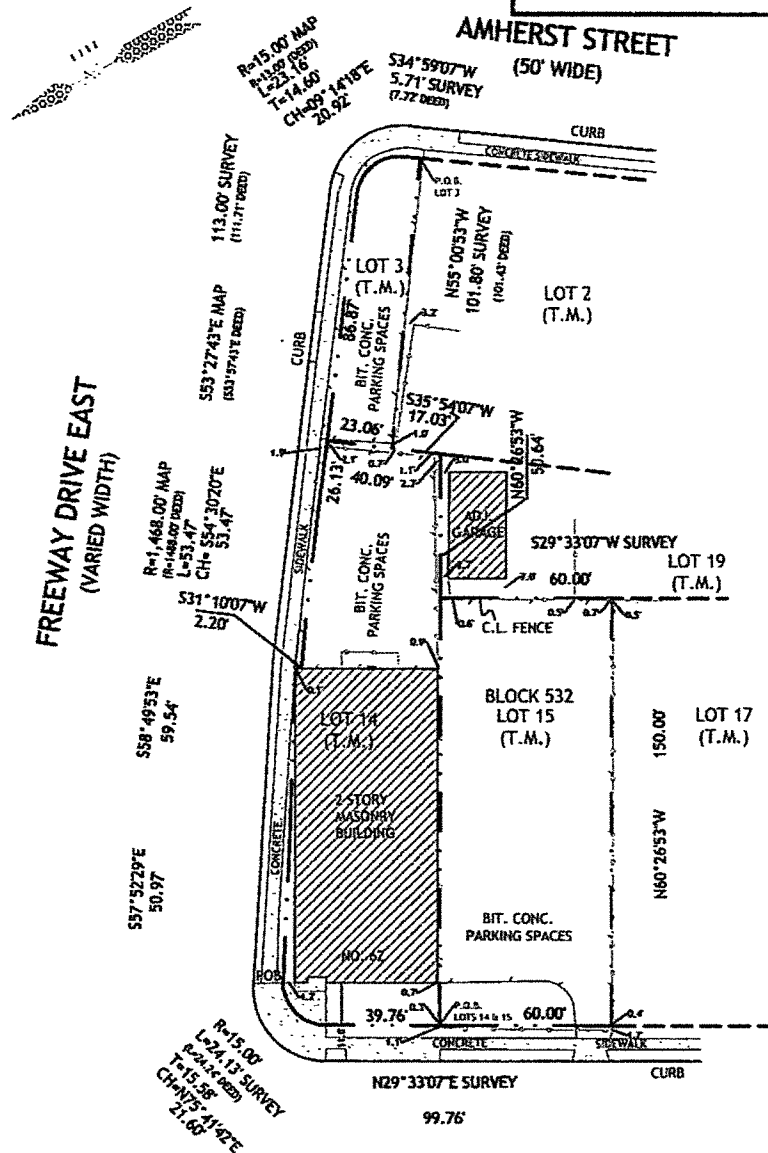

1. Along the said line Freeway Drive East the following five courses to wit;
 - a. South 57 degrees 52 minutes 29 seconds East, 50.97 feet, thence;
 - b. South 58 degrees 49 minutes 53 seconds East, 59.54 feet, thence;
 - c. South 31 degrees 10 minutes 07 seconds West, 2.20 feet, thence;
 - d. On a curve bearing to the right with a radius of 1,468.00 feet and an arc length of 53.47 feet" thence;
 - e. South 53 degrees 27 minutes 43 seconds East, 26.13 feet, to the northerly corner of Lot 3, thence;
2. Along the northwesterly line of the said lot, South 35 degrees 54 minutes 07 seconds West, 40.09 feet, to the easterly corner of Lot 19, thence;
3. Along the northeasterly line of the Lots 19 & 15, North 60 degrees 26 minutes 53 seconds West, 200.64 feet, to the said line of Halsted Street, thence;
4. Along the said line, North 29 degrees 33 minutes 07 seconds East, 39.76 feet, to a point of curvature, thence;
5. Still along the same, on a curve bearing to the right with radius of 15.00 feet and an arc length of 24.13 feet, to the point and place of beginning.
