This ±3,140 SF industrial suite (Units 1A and 2A combined) is housed in a masonry building constructed in 1989, offered move-in-ready. The suite features two 12' grade-level roll-up doors positioned centrally, flanked by separate office/man-door entrances on each end, plus a ±500 SF second-floor bonus loft office above 2A with newly remodeled office and restroom finishes.

Warehouse clear height is 16', with two evaporative coolers serving the warehouse space. Six reserved parking spaces are assigned to the suite. The 2B loft office is included at no additional charge.

Located at the corner of Joni Drive and Velie Way, just off Cook Street in Palm Desert's established industrial corridor, the property offers quick access to the I-10 Freeway via the Cook Street interchange.

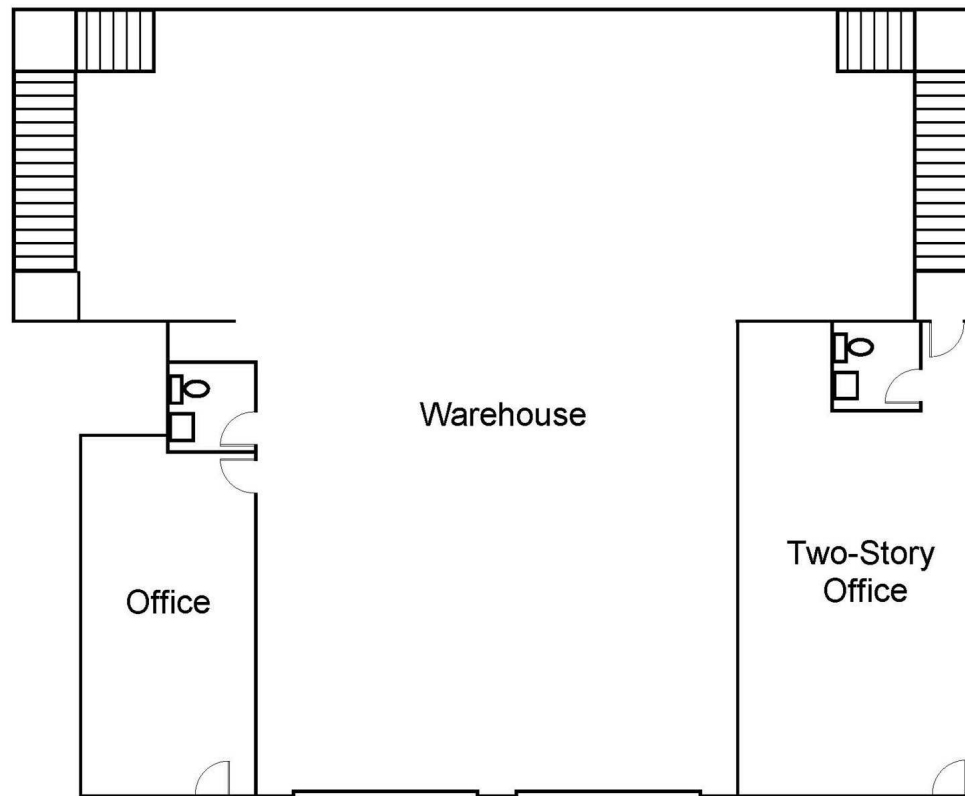

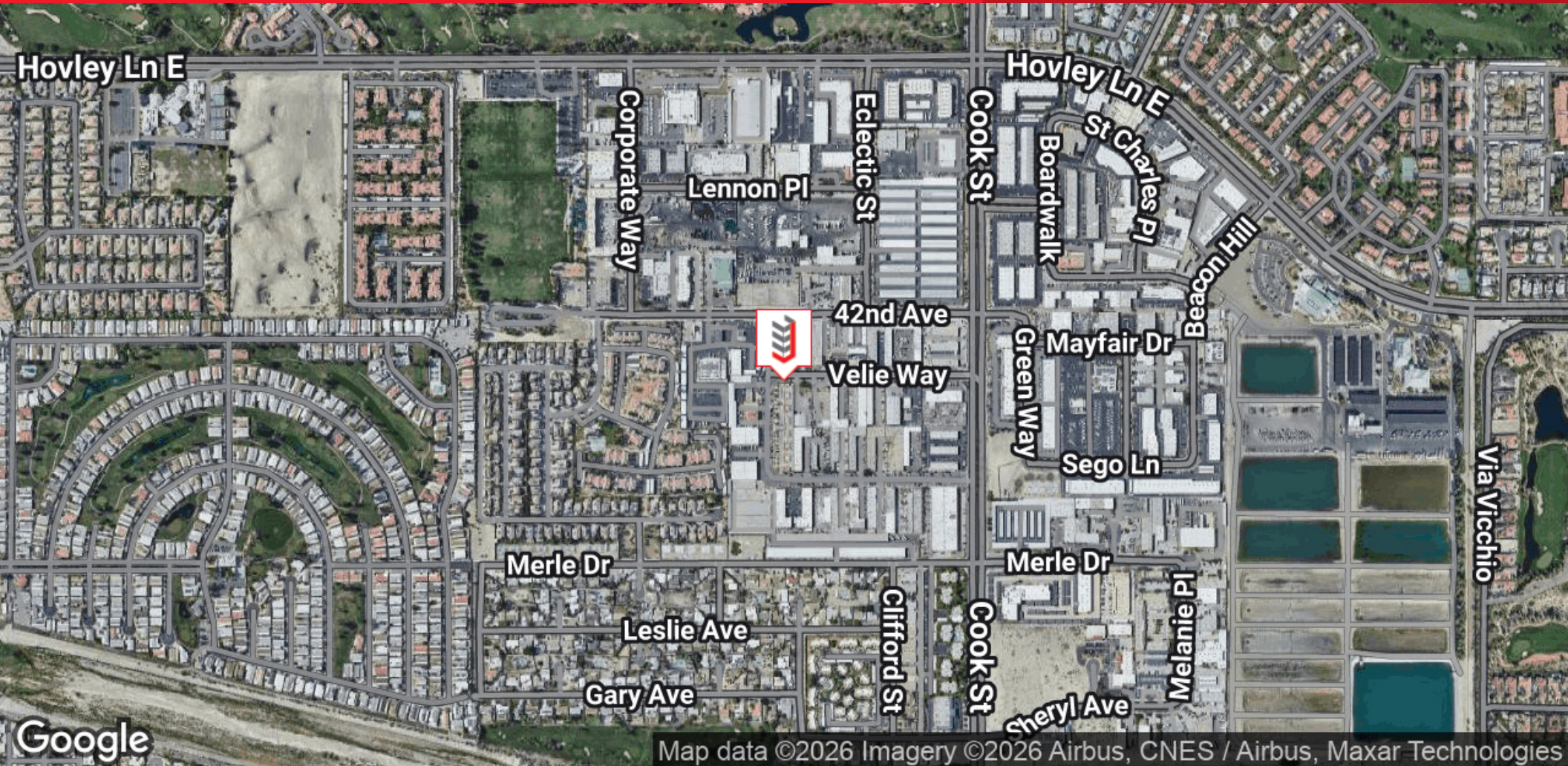
